GENERAL RULES AND REGULATIONS

Selection Process: All applications go through a selection process – and are dated as they are received.

Booth Location Requests: Fairgrounds staff will attempt to satisfy booth location requests. ***SPECIAL NOTE: VENDORS RETURNING FROM Fall 2018 Garage Sale Event WILL ONLY HAVE UNTIL February 18, 2019 TO SECURE the same space for Spring 2019. *** If you were a Vendor in Fall 2018 and you want to return, but move to a new space, you will also need to wait until after February 18, 2019 to see your requested space has been vacated by a non-returning vendor.

Exclusivity: THE SKAGIT COUNTY FAIRGROUNDS DOES NOT OFFER EXCLUSIVITY ON PRODUCTS OR SERVICES.

Payment Schedule: Your Signed Contract is due with your space fee no later than **February 25, 2019** and payment may be made by cash, check, MasterCard, or Visa. Failure to pay the space fee in full by the due date may result in cancellation of the contract.

If accepted, vendor's agrees that:

- 1. Subletting or apportioning space is prohibited.
- Food sales or giveaways MUST apply for permit or exemption from the Skagit County Health Department.
- 3. They will comply with all federal, state, and local laws, including but not limited to laws relating to sanitation and health.
- They will report and pay all federal, state, and local taxes due as a result of operation under this agreement.
- 5. They will attend and open your booth the entire time the Garage Sale is in operation.
- They are restricted that all activities and advertising matter is done in your assigned space, within established parameters.
- 7. They will abide by all conditions, rules, and regulations, written or oral, made by Fairgrounds Management at any time.
- 8. The Fairgrounds Management may, at their sole discretion, close any booth deemed inappropriate, hazardous, or in violation of Fair rules and regulations including those established by the County Risk, Health Department and City of MV Fire Departments.

Food Vendors MUST provide:

- General Comprehensive Liability Insurance with a minimum of One Million Dollars (\$1,000,000.00)
 Combined Single Limit Per Occurrence and One Million Dollars (\$1,000,000.00) Aggregate for bodily injury to one or more persons and property damage. The certificate must name as Certificate Holder: Skagit County, Attn: Fairgrounds, 1800 Continental Place, Mount Vernon, WA 98273. The following additional insured language must be included on certificate of liability insurance: "Skagit County, its officials, employees and agents"
- Evidence of current/valid Skagit County Health Department Permit for April 12-13, 2019.

Additional Requirements for Food Vendors:

Post your menu with prices of all items in a prominent place.

Provide own commercial grade extension cords where necessary.

We would appreciate all Trailers being skirted but it is not required.

All food concessions must be in compliance with Title 51 RCW relating to workers' compensation.
