PUBLIC HOSPITAL DISTRICT NO. 1 PROPOSITION NO. 1

HOSPITAL IMPROVEMENT GENERAL OBLIGATION BONDS - \$62,100,000

The Commission of Public Hospital District No. 1 adopted Resolution Nos. 2079 and 2092 concerning a proposition to finance improvements to Skagit Valley Hospital. If approved, this ballot proposition will authorize the District to construct, furnish and equip a 200,000 square foot, hospital building that will include 120 acute care beds and emergency, critical care, obstetrics, surgical and other medical facilities and services, issue no more than \$62,100,000 of general obligation bonds maturing within twenty-five years, and levy annual excess property taxes to pay and retire the bonds, all as provided in Resolution Nos. 2079 and 2092. ANACORTES SCHOOL DISTRICT NO. 103 PROPOSITION NO. 1

REPLACEMENT OPERATION AND MAINTENANCE LEVIES

The Board of Directors of Anacortes School District No. 103 adopted Resolution No. 670 concerning a proposition for partial financing of the District's maintenance and operation expenses. This proposition would authorize the levy of the following excess taxes for the District's General Fund upon all taxable property in the District, to replace the expiring levy, to pay a portion of the District's educational operation and maintenance expenses:
