2 VOTER REGISTRATION INFORMATION

2.1 QUALIFICATION FOR VOTING

In order to become a registered voter, a person must be:

- A United States citizen, and...
- A resident of Washington State for 30 days immediately preceding the day of election, and...
- 18 years old or older on or before the day of election, and...
- Not presently denied civil rights as a result of felony conviction.

2.2 WHEN TO REGISTER

Register anytime. However, registration files close 30 days prior to an election. Mail-in registration forms must be postmarked no later than the 30-day closing date in order to be eligible to vote.

Persons who do not register by the 30-day deadline may register <u>in person</u> at the Skagit County Auditor's Office during a special registration period between the 30th day and the 15th day prior to an election.

2.3 REGISTRATION DEADLINES

November 7, 2006 General Election

30 day deadline = October 7, 2006

15 day deadline = October 23, 2006

2.4 WHERE TO REGISTER

Registration can be done either in person or by obtaining a mail-in registration form from any of the following locations:

- Skagit County Auditor's Office
- Cascade Mall Information Desk
- Chambers of Commerce
- City/Town Halls
- Post Offices
- Public Libraries

- Public Schools
- Senior Service Centers
- Vehicle Licensing Offices
- State Agencies including Department of Motor Vehicles

In addition, a voter registration form can be downloaded online at www.secstate.wa.gov/elections/register.aspx, or requested by calling the Skagit County Elections Department at (360) 336-9305.

2.5 WHEN TO TRANSFER

When moving from one address to another within Skagit County, the new address must be reported to the Elections Department at least 30 days before the next election. Contact the Elections Department by phone at (360) 336-9305, by mail, by email, or in person. A new registration card showing your new precinct will be issued and mailed. If you are moving from another county or state, a new registration form must be completed.

2.6 NAME CHANGE

In order to change a name in voting records, a new registration form must be completed with the new signature. This can be done using the mail-in voter registration form obtained at any of the locations listed above.

2.7 WHERE TO VOTE

Skagit County is an all vote-by-mail county. All voters in Skagit County receive their ballots in the mail and return their voted ballots to the Elections Department by mail, or at a drop-off location; drop-off locations for the September 19th, 2006 General Election are listed below. Instructions for voting and returning the ballot are included with the ballot. Please note that your voted ballot must be postmarked no later than Election Day. Make sure you know the last pick-up time of your post office—ballots deposited after that time on Election Day are postmarked the <u>next day</u> and are not counted! If you are unsure what to do, use one of the drop-off locations below. Please also be sure you sign the return envelope!

2.8 VOTER REGISTRATION CARDS

Skagit County registration cards are not a form of identification and they are not proof of United State Citizenship, per Public Law 104-99. Voters are not required to show their registration card in order to vote. If you would like a replacement card, please notify the Skagit County Elections Department.

2.9 SPECIAL "SUBMARINE BALLOTS"

Any registered voter who completes an application stating that he or she is unable to vote and return a ballot by normal mail delivery within the period provided, may request a special ballot, a "submarine ballot."

2.10 DISABILITY ACCESS

For voters needing assistance with physical disability issues, the Skagit County Elections office is a designated accessibility site. Please call (360) 336-9305 for further information.

3 MAIL BALLOT DIRECTIONS

PLEASE READ CAREFULLY! The instructions below apply to the November 7th General Election.

3.1 STEP 1, ITEMS IN YOUR BALLOT PACKET

Your ballot packet includes the following:

- A ballot
- A white secrecy envelope
- A lavender mailing envelope
- Instructions

3.2 STEP 2, VOTE YOUR BALLOT

- 1. Use a blue or black ink pen to mark your ballot. Please do not use pencil or felt tip pen.
- 2. Completely blacken the box to the left of your desired selection.
- 3. To write in a candidate, blacken the box to the left of "Write-in," then write their name AND party on the line provided under the desired position.
- 4. Do not write or make any mark of identification on the ballot.
- 5. If you make a mistake voting your ballot, please "X" out the incorrect choice and fill in the box corresponding to the correct selection.
- 6. After you have finished voting, place your completed ballot into the white security envelope and seal.
- 7. Next, place the white security envelope inside the lavender mailing envelope and seal.
- 8. Sign and date the Affidavit of Absentee Voter on the back of the lavender mailing envelope. Your ballot cannot be processed unless the Affidavit is signed.
- 9. Please note that power of attorney is not recognized. If the voter cannot sign the mailing envelope, two people must witness the voter's "X" or other mark on the mailing envelope. The witnesses must also write "Witnessed By," then sign their names. Witnesses are not required to be registered voters.
- 10. To request a replacement ballot, call the Elections Department at (360) 336-9305.

3.3 STEP 3, RETURN YOUR VOTED BALLOT

There are three ways to return your ballot:

- 1. Mail. Mail the lavender mailing envelope containing the ballot inside the privacy envelope. It requires first class postage if mailed within the United States. It must be postmarked no later than Election Day, November 7th, 2006.
- 2. In-Person Delivery. As soon as you receive and vote your ballot, you may deliver it to the Skagit County Auditor's Office, 700 South Second Street Room 201, Mount Vernon, Washington, during regular business hours, 8:30 a.m. 4:30 p.m. As noted in section <u>Drop-Off Locations</u>, there is a 24-hour ballot drop-off box at this address.
- 3. **Drop-Off Locations**. On Election Day you may deliver your ballot to a drop-off location in Skagit County between the hours of 7:00 a.m. 8:00 p.m.; see section <u>Drop-Off Locations</u> for a list of drop-off sites. Remember that there is also a 24-hour drop-off ballot box at the Skagit County Auditor's Office.

Please note:

- Any person who votes when he or she is not entitled, attempts to vote more than once, or falsely signs the affidavit, is guilty of a felony, punishable by imprisonment for not more than five years or a fine of not more than ten thousand dollars, or both such fine and imprisonment. RCW 29A.40.091 and RCW 29A.84.660 and RCW 29A.84.680.
- In Washington State, every voter has the right to vote his or her ballot in secret.

4 2006 GENERAL ELECTION CANDIDATES' STATEMENTS

4.1 INTRODUCTION

On the following pages are statements by and for candidates for Skagit County offices. Please note the following:

- Statements are for candidates for Skagit County offices only. No statewide contests, or contests that contain areas outside Skagit County, are included.
- The only statements are those sent by candidates—no statements were solicited by the Elections Department. If a statement is not found for a particular candidate, it means that candidate did not send a statement to the Elections Department.
- Contests for which no statements were received, such as Treasurer, are not included.
- No editing for form or correctness of content has occurred—statements are exactly as sent by the candidates.
- Statements are in the following order:
 - First, alphabetic by office;
 - Within office, Democratic candidates' statements are first, followed by Republican candidates' statements;
 - ➤ In non-partisan offices, statements are in the order candidates appear on the ballot.

4.2 ASSESSOR

4.2.1 DEMOCRATIC CANDIDATE

There is no Democratic candidate for Assessor.

4.2.2 MARK LEANDER, REPUBLICAN CANDIDATE

Mark Leander has been with the Assessor's office since 1986. His first position was as Residential Appraiser, later being promoted to Sales Analyst. In 1994 he was elected Skagit County Assessor and re-elected in 1998 and 2002.

He has been committed to public access of information, having been instrumental in developing the first Assessor's website making property value information available to the public. Under his direction, the office has published an annual update of property tax procedure information, a step to educate the public in State law and procedures regarding property taxation.

Under his management, the Skagit County Assessor's Office has repeatedly performed in the top 10% of Washington State counties in Accuracy and Equity as measured by standards set by the International Association of Assessing Officers.

Mark Leander is a member of the Washington State Association of County Assessors, and has served as Secretary-Treasurer, Vice President and President. Through these associations Mark has represented Skagit County diligently in all aspects of property taxation issues at the state level.

Opponents ignore the fact that water fluoridation has been used for 60 years and is safe, effective and inexpensive. More than 170 million Americans, including Anacortes residents, drink fluoridated water to improve oral health.

Fluoride is already in our water naturally. A slight adjustment can reduce dental decay up to 40%. The EPA regulates fluoridation of public water supplies, not the FDA.

Fluoridated water costs less than \$1/year per person. A tax increase is not necessary; a non-profit foundation will pay for the equipment.

Unproven claims by one Tacoma dentist are rejected by local and national medical and dental associations - representing thousands of health professionals.

Ask your physician/dentist about the benefits of fluoridation. Prevent painful dental disease and save money - Vote Yes on Proposition 2.

Statement in Opposition to Proposition 2

VOTE NO ON PROPOSITION #2 - KEEP OUR WATER SAFE AND CLEAN



Skagit County residents should reject adding hydrofluorosilicic acid (fluoride) to the county water supply. This compound is a by-product of the phosphate-fertilizer industry and contains contaminants heavy metals such as lead and arsenic.

On November 8, 2005, Bellingham voters rejected adding fluoride compounds in their water supply even

after fluoride proponents spent over \$250,000 on a Seattle based campaign. Skagit County voters should reject the forced fluoridation proposal as well.

Regardless of one's view, each individual has the right to determine what medications or supplements to ingest, not the government.

Reject needless tax increases. The initial cost estimate from the Skagit PUD report would be \$800,000 plus over \$58,000 per year. Cost overruns will be tax-payers' responsibility.

On August 5, 2005, EPA unions representing 7000 scientists have called on Congress to institute a <u>national moratorium on water fluoridation</u>.

Washington Dentists such as Debra Hopkins oppose water fluoridation:

"[t]here are studies linking water fluoridation to increased hip fracture in the elderly, bone cancer in young males, increased lead uptake in children, thyroid disease, arthritis and harm to our environment."

The FDA has never approved fluoride compounds as being safe and effective for ingestion. Fluoride is a chemical, not an essential nutrient.

Because there are significant health risks, keep fluoride compounds out of our water supply, streams and especially out of our bodies. Each Skagit County resident is entitled to choose what they ingest each day.

Since 1997, the evidence against fluoridation is much stronger. Eleven separate EPA scientist unions with over 1500 members have called for a moratorium on fluoridation. A Harvard University Study in 2005 has linked water fluoridation with bone cancer (Osteosarcoma) in young boys.

Most European countries and most of Canada reject fluoridation. Many U.S cities have also rejected fluoride.

Nevertheless, the fluoridation proponents seek to force fluoride into our water supply in Skagit County.


