VOTER REGISTRATION INFORMATION

Qualifications For Voting

To become a registered voter, a person must be:

- A United States citizen, and...
- A resident of Washington State for 30 days immediately preceding the day of election, and...
- 18 years old or older on or before the day of election, and...
- Not presently denied civil rights as a result of felony conviction.

When To Register

Register anytime. However, registration files close 30 days prior to an election. Mail-in registration forms and transfers must be postmarked no later than the 30-day closing date in order to be eligible to vote.

Persons who are not currently registered in Washington State, and do not register by the 30-day deadline, may register in person at the Skagit County Auditor's Office during a special registration period between the 30th day and the 15th day prior to an election.

Registration Deadlines

November 4th, 2008 General Election
 30 day deadline for mail-in registrations and transfers = October 4th, 2008
 15 day in-person deadline = October 20th, 2008

Where To Register

Register in the following ways and places.

- Register in-person at the Skagit County Auditor's Office at: 700 South Second Street, Room 201 Mount Vernon, WA. Monday through Friday, 8:30 AM to 4:30 PM

 - Most Post Offices
 - Public Libraries

When To Transfer

When moving from one address to another within Skagit County, the new address must be reported to the Elections Department at least 30 days before the next election. Contact the Elections Department by phone at (360) 336-9305, by mail, by email, or in person. A new registration card showing your new precinct will be issued and mailed. If you are moving from another county or state, a new registration form must be completed.

Name Change

In order to change a name in voting records, a new registration form must be completed with the new signature. This can be done using any of the methods listed above.

Where To Vote

Skagit County is an all vote-by-mail county. All voters in Skagit County receive their ballots in the mail and return their voted ballots to the Elections Department by mail, or at a ballot drop-box location listed below. Instructions for voting and returning the ballot are included with the ballot. Please note that your voted ballot must be postmarked no later than Election Day. **Make sure you know the last pick-up time of your post office**—ballots deposited after that time on Election Day are postmarked the <u>next day</u> and are not counted! If you are unsure what to do, use one of the drop-off locations listed below. Please also be sure you **sign the return envelope!**

Voter Registration Cards

Skagit County registration cards are not a form of identification and they are not proof of United States' Citizenship, per Public Law 104-99. Voters are not required to show their registration card in order to vote. If you would like a replacement card, please notify the Skagit County Elections Department.

Special "Submarine Ballots"

Any registered voter who completes an application stating that he or she is unable to vote and return a ballot by normal mail delivery within the period provided, may request a special ballot, a "submarine ballot."

Disability Access

For voters needing assistance with physical disability issues, the Skagit County Elections office is a designated accessibility site. Please call (360) 336-9305 for further information.

MAIL BALLOT DIRECTIONS

PLEASE READ CAREFULLY! The instructions below apply to the November 4th, 2008 General Election.

Step 1, Items In Your Ballot Packet

Your ballot packet includes the following:

- A ballot
- A white secrecy envelope

- A colored mailing envelope
- Instructions

Step 2, Vote Your Ballot

- 1. Use a blue or black ink pen to mark your ballot. Do not use pencil or felt tip pen.
- 2. Completely blacken the box to the left of your desired selection.
- 3. To write in a candidate, blacken the box to the left of "Write-in," then write their name AND party on the line provided under the desired position.
- 4. Do not write or make any mark of identification on the ballot.
- 5. If you make a mistake voting your ballot, please correct it by drawing a line through the candidate's name, then make another choice if desired.
- 6. After you have finished voting, place your completed ballot into the white security envelope and seal.
- 7. Next, place the white security envelope inside the colored mailing envelope and seal.
- 8. Sign and date the Affidavit of Absentee Voter on the back of the colored mailing envelope. Your ballot cannot be processed unless the Affidavit is signed.
- 9. Please note that power of attorney is not recognized. If the voter cannot sign the mailing envelope, two people must witness the voter's "X" or other mark on the mailing envelope. The witnesses must also write "Witnessed By," then sign their names. Witnesses are not required to be registered voters.
- 10. To request a replacement ballot, or for any other questions, call the Elections Department at (360) 336-9305.

Step 3, Return Your Voted Ballot

There are three ways to return your ballot:

- 1. **Mail**. Mail the colored mailing envelope containing the ballot inside the privacy envelope. It requires first class postage if mailed within the United States. It must be postmarked no later than Election Day, November 4th, 2008.
- 2. **In-Person Delivery**. As soon as you receive and vote your ballot, you may deliver it to the Elections Department in the Skagit County Auditor's Office, 700 South Second Street Room 201, Mount Vernon, Washington, during regular business hours, 8:30 AM 4:30 PM. As noted in section <u>Drop-Off Locations</u>, there is also a 24-hour ballot drop-off box in the parking lot at this address.
- 3. **Ballot drop-box Locations**. From the day you first receive your ballot until 8:00 PM Election Day you may deposit your ballot in any of the ballot drop-boxes listed in section <u>Drop-Off Locations</u>. Remember that these locations are all open 24 hours a day during that period.

Ballot Instructions

- Use a black or blue pen to mark your ballot.
- To vote your choice in each contest, completely fill in the box to the left of your choice.
- To vote for a write-in candidate, completely fill in the box to the left of the words "Write-in" and write in the name.
- More than one vote in a contest is an overvote, and no votes for that contest will be counted. If you do not want to vote a particular contest, you can leave it blank.
- If you make an error, draw a line through the text of the candidate's name or ballot measure response, then fill in the box corresponding to your desired choice. You may also call the Skagit County Elections Department at (360) 336-9305 to request a new ballot if your current ballot has been spoiled.
- If you sign or otherwise identify yourself on the ballot, the ballot will not be counted.
- Complete and sign the declaration on the return envelope. If you are unable to sign, make your mark and have it witnessed by TWO people. Make sure they both sign the envelope.

- Place your voted ballot in the white secrecy envelope, seal that envelope, then place the white secrecy envelope in the colored return envelope and seal that envelope.
- If you are returning your ballot by postal service, affix First Class postage to the return envelope. If you use a drop box, NO POSTAGE IS REQUIRED.
- Your ballot must be postmarked no later than Election Day, November 4th, 2008. Make sure you know the last pick-up time of your post office; ballots deposited after that time on Election Day are postmarked the next day and not counted!
- If you do not want to mail your ballot, deposit it in one
 of the ballot drop-boxes listed above. All locations are
 operational as soon as you receive your ballot, and all
 are open 24 hours a day. All boxes close 8:00 PM on
 Election Day.

City of Sedro-Woolley
Proposition No. 1
Fire Department Acquisition and Improvement Bonds - \$2,000,000

The City Council of the City of Sedro-Woolley passed Ordinance No. 1617-08 concerning this proposition. This proposition authorizes the City to construct and equip fire station #2 and acquire a fire engine and a ladder truck, issue general obligation bonds in the principal amount of \$2,000,000, maturing within a maximum of twenty years, and levy property taxes annually in addition to regular tax levies to repay such bonds, all as provided in Ordinance No. 1617-08. Should this proposition be: Approved [] Rejected []

Explanatory Statement

Statement regarding Sedro-Woolley Proposition 1, the Sedro-Woolley Fire Department Acquisition and Improvement Bonds.

If approved, Proposition 1 will authorize the City of Sedro-Woolley to issue bonds in an amount not to exceed \$2,000.000, to build Fire Station 2, to purchase and equip a new ladder truck and to purchase and equip a new fire engine.

Fire Station 2. Fire Station 2 will be built on Portobello Drive just off of Fruitdale Road on property already owned by the City. Station 2 will increase the Fire Department's capacity to respond to calls by adding a new station to the North side of town. Station 2 will include two vehicle bays to accommodate a fire engine and an aid vehicle. Station 2 will also include space for future sleeper units, allowing the Fire Department to respond to calls more quickly at night and on the weekends. The City planning department estimates that the part of Sedro-Woolley that is East of State Route 20 will eventually grow to 8,000 people. Station 2 will allow the Fire Department to respond more quickly today and be ready for the growth of the future.

Ladder Truck. National standards require the Fire Department to have a ladder truck to serve several dozen buildings in the City today. Some of those buildings include United General Hospital, Sedro-Woolley High School, Janicki Industries and most of the buildings downtown. If approved, this bond will allow the Fire Department to purchase and equip a ladder truck with a 110 foot tall ladder.

Fire Engine. The third element of this bond proposal is the purchase of a new fire engine which will allow the Fire Department to locate an engine at Fire Station 2.

If approved, the impact of this bond on a Sedro-Woolley homeowner is estimated at \$.17 per \$1,000.00 in assessed value, or for a \$250,000.00 home, approximately \$3.54 per month. Measure Statement: Public Utility District No. 1

Public Utility District No. 1 Proposition No. 1

Shall Public Utility District No. 1 of Skagit County construct or acquire electric facilities for the generation, transmission or distribution of electric power?

Explanatory Statement

If approved by the voters of the Public Utility District No. 1 of Skagit County, this measure will give PUD No. 1 authority to acquire, construct, operate, maintain and add to electrical systems and provide electrical services to those customers in the public utility district. By Resolution No. 2134-08 the Commission of Skagit PUD No. 1 is presenting this measure to the voters for their approval.

If approved, Skagit PUD No. 1 has agreed to fund an updated feasibility study for the acquisition of existing electric power facilities in Skagit County. Electric Services are currently provided by Puget Sound Energy.

Approval of this measure will place with the elected local PUD commission decision-making responsibility regarding operation, maintenance, rate-setting and other electric utility issues for any electric facilities acquired or constructed.

Explanatory statement prepared by Peter A. Gilbert, Attorney for District

Statement in favor of Public Utility District Proposition No. 1

If voters approve this measure, Skagit PUD Number 1 has agreed to fund an in-depth study of the feasibility of acquiring existing electric power facilities in Skagit County. The PUD commissioners placed the issue on the ballot and have asked the voters to register their opinion.

Measure Statement: Skagit Transit System

Skagit County Public Transportation Benefit Area Proposition No. 1

Shall public transportation services in Skagit County be maintained and improved by authorizing the Skagit Transit System to impose an additional two-tenths $(2/10^{ths})$ of one percent (1%) sales tax, effective January 1, 2009?

Explanatory Statement

If approved by the voters, this measure will authorize the Skagit Transit System to increase the sales and use tax from two-tenths of one percent (0.2%) to four-tenths of one percent (0.4%), within the Public Transportation Benefit Area, effective January 1, 2009. The result upon approval will be an increase of two cents (\$.02) for every ten dollars (\$10.00) sales transaction. Washington State statutes provide transit agencies taxing authority of up to ninetenths of one percent (0.9%) of sales and use tax. The purpose of this tax is to maintain and improve public transportation services within the Public Transportation Benefit Area.

The increase in revenue will replace, in part, state and federal grants scheduled to expire in June 2009. The revenue generated by this increase would be used solely for operation, maintenance and capital needs. The revenue will allow the Skagit Transit System to continue to offer existing levels of service and to expand service and would also allow for replacement and purchase of vehicles in order to meet the current and future needs in the Skagit Transit service area.
