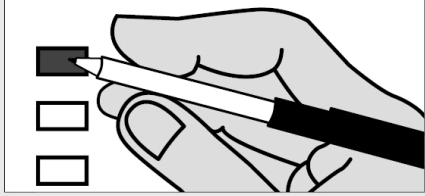

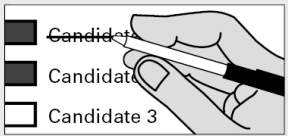
Instructions
