WITNESSETH:

Government Lot 1 in Section 33, Township 36 North, Range 3 East of the Willamette Neridian, EXCEPT reads, EXCEPT dike and ditch rights of way and EXCEPT that portion of said property conveyed to Diking District No. 4 of Skagit County, Washington, a corporation, by an instrument dated October 1, 1934, filed November 13, 1934 as File No. 265758 and recorded in Volume 166 of Deeds at Page 237

That portion of the southwest quarter of the northwest quarter and of Government Lot 2 in Section 33, Township 36 North, Range 3 east of the Willamette Meridian, described as follows:

Beginning at a point on the Morth line of said southwest quarter of the morthwest quarter which is 188.2 feet East of the Morthwest corner of said southwest quarter of the Morthwest quarter; thence South 54°05' West 167 feet to a point 53 feet East of the West line of said Section; thence South 1145.3 feet; thence south 87°03' East 195.9 feet to a point; thence South 0°34' East 220 feet, more or less, to the Morth Samish River; thence Westerly along said river bank to the Southeast corner of a tract deceded to Margaret A. Together with the right of ingress to and egress from said lands across adjacent lands of the Grantor 5 for the purpose of constructing, reconstructing, repairing, renewing, altering, changing, patrolling and operating said line, and the right at any time to remove said poles, wires and appurtenances from

Also the right at all times to cut all brush and timber, and trim all trees standing or growing upon said lands which, in the opinion of the Grantee, constitute a menace or danger to said line.

The Grantors., their heirs, successors or assigns, covenant. and agree — not to do any blasting or discharge any explosives within a distance of three hundred (300) feet of said line without giving reasonable notice in writing to the Grantee, its successors or assigns, of intention so to do.

The rights, privileges and authority hereby granted shall continue and be in force until such time as the Grantee, its successors or assigns, shall permanently remove said poles, wires and appurtenances from said lands, or shall otherwise permanently abandon said line, at which time all such rights, privileges and authority hereby granted shall terminate.

Any mortgage on said land held by the Mortgagee is hereby subordinated to the rights herein granted to the Grantee, but in all other respects the said mortgage shall remain unimpaired.
