


LEGAL DESCRIPTION

THAT PORTION OF THE NORTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 17 TOWNSHIP 35 NORTH RANGE & EAST W.M. DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE WEST LINE OF SAID NORTHEAST 1/4 OF THE NORTHWEST 1/4 745 FEET SOUTH OF THE NORTHWEST CORNER THEREOF THENCE SOUTH ALONG SAID WEST LINE A DISTANCE OF 442 FEET; THENCE EAST 447 FEET, MORE OR LESS, TO THE WEST LINE OF THAT CERTAIN TRACT OF LAND CONVEYED TO GEORGE KINDY BY DEED DATED JULY 14, 1899 AND RECORDED JULY 15, 1899 IN VOLUME 36 OF DEEDS, PAGE 598 RECORDS OF SKAGIT COUNTY WASHINGTON; THENCE NORTH ALONG THE WEST LINE OF THE GEORGE KINDY TRACT TO A POINT WHICH IS EAST OF A POINT THAT IS 353 FEET NORTH AND 322 FEET EAST OF THE SOUTH-WEST CORNER OF SAID NORTHEAST 1/4 OF THE NORTHWEST 1/4, SAID POINT BEING ON THE SOUTH LINE OF THAT CERTAIN TRACT OF LAND CONVEYED TO ORLEN HOBSON BY DEED DATED FEBRUARY 4, 1911 AND RECORDED JUNE 8, 1911 UNDER A.F. # 85174 IN VOLUME 82 OF DEEDS, PAGE 509 RECORDS OF SKAGIT COUNTY, WASHINGTON; AND SAID SOUTH LINE PROJECTED EASTERLY; THENCE WEST ALONG THE SOUTH LINE OF SAID HOBSON TRACT AND SAID SOUTH LINE PROJECTED TO THE SOUTHWEST CORNER OF SAID HOBSON TRACT SAID POINT BEING 353 NORTH AND 322 FEET EAST OF THE SOUTHWEST 1/4 OF SAID NORTH - EAST 1/4 OF THE NORTHWEST 1/4; THENCE NORTH ALONG THE WEST LINE OF SAID HOBSON TRACT A DISTANCE OF 200 FEET TO THE NORTHWEST CORNER THEREOF; THENCE CONTINUE NORTH TO A POINT THAT IS EAST OF THE POINT OF BEGINNING; THENCE WEST TO THE POINT OF OF THE POINT OF BEGINNING; THENCE WEST TO THE POINT OF BEGINNING; EXCEPT THEREFROM THAT CERTAIN 16 FOOT WIDE STRIP OF LAND CONVEYED TO THE TOWN OF LYMAN BY DEED DATED MARCH 23, 1968 AND RECORDED APRIL 30, 1968 UNDER A.F. # 713132, SAID IL FOOT STRIP BEING DESCRIBED AS FOLLOWS

A STRIP OF 16 FEET IN WIDTH LYING ADJACENT TO, AND NORTH OF THE NORTH LINE OF LOT ONE (1) IN BLOCK 2 OF CENTRAL ADDITION TO THE TOWN OF LYMAN AS PER PLAT RECORDED IN VOLUME 4 OF PLATS, PAGE 2, RECORDS OF SKAGIT COUNTY AND EXTENDING FROM THE WEST LINE OF REECE AVENUE, AS SHOWN IN SAID PLAT WESTERLY ALONG THE WESTERLY PROJECTION OF THE NORTH LINE OF SAID LOT ONE (1) TO ITS INTERSECTION WITH THE ALLEY AS IT NOW EXISTS ALONG THE EASTERLY LINE OF THE CEMETARY, ALL BEING LOCATED IN THE NORTHEAST 1/4 OF THE NORTHWEST 1/4 OF SEC. 17, TOWNSHIP 35 NORTH, RANGE 6 EAST W.M.
