Pursuant to RCW 64.32.090 (13) and subparagraph 22.3 of the Condominium Declaration of the Anacortes Marina Condominium recorded on June 1, 1981, under Skagit County Auditor's File No. 8106010012, the undersigned Declarant has added, revised, amended, and/or modified the following provisions of said Declaration:

1. 23.5 Restriction Upon Sales or Assignments (NEW)

No owner shall have the right to sell, assign, and/or transfer his apartment and/or moorage slip or any interest therein without the prior written consent of Declarant which consent shall not be unreasonably withheld provided any owner desiring to sell, assign, or transfer any interest in owner's apartment and/or moorage slip shall have provided Declarant (or the Association, after the period provided in subparagraph 10.1) with the name and address of any purchaser, assignee, transferee, or successor owner of any such apartment and/or moorage slip.

2. Subparagraphs 23.5, 23.6, 23.7, and 23.8 of said Condominium Declaration are renumbered as subparagraphs




