PARCEL "A":

That portion of the Southeast 2 of the Northwest 2 and of the Southwest 2 of the Northeast 2 of Section 21, Township 33 North, Range 4 East W.M., described as follows:

Beginning at a point on the North-South centerline of said Section 21, which is on the North line of a strip of land 20 feet wide, conveyed to Skagit County for road purposes by Deed recorded March 2, 1956 under Auditor's File No. 532429, the centerline of which intersects the said North-South centerline at a point North 0°34'23" Fast, 413.12 feet from the center of said Section; thence continue North along the said centerline of said Section to a point lying North 0°34'23" East, a distance of 575.71 feet from the center of said Section; thence South 06°44'47" West, a distance of 142.67 feet, more or less, to the North line of the aforementioned 20 foot strip, which point is the true point of beginning; thence North 06°44'47" East, a distance of 142.67 feet, more or less, to the aforementioned point which lies North 00°34'23" East, a distance of 575.71 feet from the center of said Section 21; thence South 85°10'46" West, a distance of 119.60 feet; thence North 53°41'33" East, a distance of 96.57 feet; thence North 07°20'08' West, a distance of 46.91 feet to the South line of a second strip of land conveyed to Skagit County for road purposes by the aforementioned Deed recorded March 2, 1956 under Auditor's File No. 532429, thence following the said South line of said second strip, Easterly a distance of 75 feet to a point where there is buried a stake in the ground; thence due South from said stake buried in the ground to the North line of the first 20 foot strip above described, thence following the North line of said first 20 foot strip Westerly, a distance of 80 feet, more or less, to the true point of beginning; EXCEPT therefrom that portion, if any, lying within the boundaries of that certain railroad right of way as conveyed to Fred Nieshe, et ux, by deed recorded under Auditor's File No 796721, records of Skagit County, Vashington.
