HARTMAN, are owner(s) of Lot No. 144, Skyline Division No. 6, as the same is of record in the office of the Skagit County Auditor, in Volume 9 of Plats, page 64, which abuts upon Tracts A, B, C and D of the Skyline Development, which ~~are~~ is established as green belt and ~~are~~ owned by the corporation. ~~(I)~~ (We) either desire to or have already placed flowers, shrubs, lawn and/or other horticultural growths upon the green belt area abutting ~~(my)~~ (our) property, to a depth of 4 in Tract A, for the purpose of assisting in the beautification of the general area as well as enhancing the appearance of ~~(my)~~ (our) real estate.

~~(I)~~ (We) acknowledge that this is done with the permission and implied consent of your corporation, that ~~(my)~~ (our) action is in no way adverse to, or designed to obtain a prescriptive right against, the corporation's ownership of the green belt, regardless of the length of time our encroachment remains upon the corporation's property. ~~(I)~~ (We) agree that upon request of your corporation, at any time, in the event you deem or believe it necessary for the appropriate protection of your property or the development of Skyline, to remove at ~~(my)~~ (our) expense any and all encroachments upon the green belt, and only ask that pending such time ~~(I)~~ (We) be permitted to continue said encroachments.

~~(I)~~ (We) acknowledge that in writing this letter ~~(I)~~ (We) bind ~~(myself)~~ (ourselves), ~~(my)~~ (our) heirs, executors, administrators, successors and assigns, and that this instrument will become appurtenant to and run with ~~(my)~~ (our) land hereinabove described.
