

LEGAL DESCRIPTION

THAT PORTION OF GOVT LOT 2 OF SECTION 19, TOWNSHIP 35 NORTH, RANGE 5 EAST, W.M., DESCRIBED AS FOLLOWS: BEGINNING AT A POINT 881.35 FEET NORTH AND 30 FEET EAST OF THE WEST QUARTER CORNER OF SAID SECTION 19; THENCE EAST A DISTANCE OF 120 FEET; THENCE SOUTH 30° EAST A DISTANCE OF 111.8 FEET; THENCE SOUTH PARALLEL WITH THE WEST LINE OF SAID LOT 2 A DISTANCE OF 59.73 FEET TO THE NORTHERN LINE OF THE GREAT NORTHERN RAILWAY COMPANY RW; THENCE NORTH 53° 02' EAST ALONG SAID RIGHT OF WAY LINE, A DISTANCE OF 223.0 FEET TO THE SOUTHWEST CORNER OF THAT CERTAIN TRACT CONVEYED TO THE STATE OF WASHINGTON, BY DEED DATED JANUARY 27, 1948, UNDER AUDITOR'S FILE NO. 417815; THENCE NORTH ALONG THE WEST LINE OF SAID STATE LAND, A DISTANCE OF 309.7 FEET TO THE SOUTH LINE OF SECONDARY STATE HIGHWAY NO. 17-A, SEDRO-WOOLLEY EASTERLY, AS CONVEYED TO THE STATE OF WASHINGTON, BY DEED DATED JANUARY 17, 1948, AND RECORDED FEBRUARY 24, 1948, UNDER AUDITOR'S FILE NO. 414775; THENCE WEST ALONG THE SOUTH LINE OF SAID STATE HIGHWAY RW 214.07 FEET; THENCE SOUTH A DISTANCE OF 215.3 FEET; THENCE WEST A DISTANCE OF 182.00 FEET TO THE EAST LINE OF THE COUNTY ROAD; THENCE SOUTH ALONG SAID COUNTY ROAD A DISTANCE OF 112.01 FEET TO THE POINT OF BEGINNING; EXCEPT ANY PORTION OF SAID PREMISES LYING WITHIN THE BOUNDARIES OF THAT CERTAIN TRACT CONVEYED TO ERNEST A. SACKMAN AND BETTY SACKMAN, HIS WIFE, BY DEED DATED MAY 28, 1951 AND RECORDED SEPTEMBER 25, 1951 UNDER AUDITOR'S FILE NO. 466032.
