


WELL NOTES

THE PRESENT AND FUTURE OWNERS OF LOT 3 OF THIS SHORT PLOT AND OF LOT 25, PLAT OF IDLEWOOD, ARE REQUIRED TO PROTECT THE PORTIONS OF SAID LOTS LYING WITHIN THE WELL PROTECTION ZONES SHOWN HEREON FROM ANY PHYSICAL, CHEMICAL, BIOLOGICAL, OR RADIOLOGIC SUBSTANCE THAT IS DELETERIOUS TO HEALTH. THESE AREAS ARE RESERVED FOR CURRENT AND FUTURE WELL PROTECTION ZONES, AND ARE INTENDED TO PROVIDE THE OWNER OF LOT 4 THE ABILITY TO CONSTRUCT A WELL HAVING A 100 FOOT RADIUS WELL PROTECTION ZONE. 


