KNOW ALL MEN BY THESE PRESENTS, That ROGER W. RICH and DOROTHY R. RICH, his wife, of the County of SKAGIT in the State of Washington, in consideration of the sum of one hundred and forty one 140/00 Dollars, paid \_\_\_\_\_ the receipt of which is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Skagit, the following described parcel of land situated in Skagit County, in the State of Washington, to-wit:

A strip of land in the West Half (W 1/2) of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section 24, Township 3<sup>4</sup> North, Range 4 East, W.M., being 30 feet in width and lying on the Easterly side, adjacent to and parallel with the following described centerline:

Beginning at the Northwest corner of said Section 24; thence South 89° 24' 22" East, 1425.98 feet to the true point of beginning, said point is on a 12.5° curve to the left and has a tangent bearing South 39° 20' 05" East; thence Southeasterly along said 12.5° curve to the left, 94.11 feet to the P.T. of said 12.5° curve; thence South 51° 05' 53" East, 177.37 feet to the P. C. of a 7.5° curve to the right; thence Southeasterly along said 7.5° curve, 308.74 feet to the P.T. of said 7.5° curve; thence South 27° 56' 33" East, 289.84 feet to the P.C. of a 1.5° curve to the right; thence Southeasterly along said 1.5° curve, 1.06 feet more or less to a point on the South line of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section 24.
