Fifth. That by an order duly passed by this Board on the 22nd day of January,

19 90, the 12th day of February, 19 90, was set for hearing the

report of the Engineer, and the consideration thereof, and that notice of the time and place where said

hearing would be held was given by publication and posting as provided by law.

Sixth. That said report of the County Engineer shows:

That in his opinion said road should be vacated.

That said XXXX alleyway is not in use.

That it will not be advisable to preserve the same for a general road system in the future.

That the public will be benefitted by its vacation.
