WHEREAS, by Easement Exchange, dated August 7, 1986, as recorded in Skagit County, Washington, in Volume 662, Page 119, under Auditor's File No. 8608150015, herein called "Original Easement Exchange," Georgia-Pacific Corporation, a Georgia corporation, by and through its Washington Wood Products Manufacturing Division, herein called "Georgia-Pacific," and Weyerhaeuser Company, a Washington corporation, granted each to the other certain road easements and access rights; and

WHEREAS, Grandy Lake Forest Associates Limited Partnership, a Washington limited partnership, herein called "Grandy Lake," has since acquired the Weyerhaeuser Company lands served by and crossed by said road easements and access rights; and

WHEREAS, Georgia-Pacific agrees that one road segment that was intended to be included in said Original Easement Exchange was inadvertently omitted from the grant to Weyerhaeuser Company and that an easement for said road segment should now be granted to Grandy Lake.

NOW THEREFORE, Georgia-Pacific hereby grants and conveys to Grandy Lake, its successors and assigns, a perpetual nonexclusive easement upon, over and along a right of way sixty (60) feet in width over and across a portion of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 19, Township 35 North, Range 7 East, W.M., Skagit County, Washington, being thirty (30) feet on each side of the centerline of the road located approximately as shown on the attached Exhibit A.

Subject as to said lands to all matters of public record.

The easement hereinabove granted shall be subject to all of the terms and conditions of said Original Easement Exchange, and except for the grant hereinabove made, the terms and conditions of said Original Easement Exchange shall remain in full force and effect.




