## MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made this  $(\rho)$  day of May, 19 $\overline{9}$ , between B & P Investments, a Washington general partnership ("Landlord") and SKAGIT VALLEY FOOD CO-OP, a not for profit corporation ("Tenant").

Landlord and Tenant entered into a Lease Agreement, dated <u>May (e, 1991</u>, pursuant to which Landlord leased to Tenant and Tenant leased from Landlord certain real property in the City of Mount Vernon, County of Skagit, State of Washington, described in Exhibit A attached to this Memorandum of Lease for a term of <u>Tenant</u> (10) years, commencing <u>July</u> (991 and ending <u>June 30, 2001</u>, together with a ten (10) year option to renew the Lease Agreement.

This Memorandum is not a complete summary of the Lease Agreement and should not be used in interpreting provisions of the Lease Agreement. In the event of conflict between this Memorandum and the Lease Agreement, the Lease Agreement shall control. This Memorandum is executed solely for the purpose of recording and making public notice of the existence of the Lease Agreement.
