ORDER OF ESTABLISHMENT Cith: Stephanie

In the matter of the County Road petitioned/requested for by the Board of Skagit County Commissioners, and others, the Board finds as follows:

FIRST. That the petition/request was filed on the 7th day of October. 1991, and petition was signed by at least ten householders of the County, residing in the vicinity of the proposed road.

SECOND. That the petition was accompanied by a bond in the sum of \$300:00, which said bond was found to be good and sufficient, and was duly approved by the Chairman of the Board on the day of 1991.

THIRD. That on the 7th day of October, 1991, the County Engineer was duly directed to examine and if necessary survey the route of said proposed road.

FOURTH. That on the 28th day of October, 1991, County Engineer filed in the office of the Board his report in writing, and at the same time a map and the field notes of said proposed road, as provided by law.

FIFTH. That by an order duly passed by this Board on the 7th day of October, 1991, the 28th day of October, 1991, was set for hearing the report of the Engineer, and the consideration thereof, and that notice of the time and place where said hearing would be held was given as provided by law.

SIXTH. The said report of the County Engineer shows:

- (1). That in his opinion said proposed is a necessity and ought to be established and opened.
- (2). The terminal points, general course and length of the road.
- (3). His recommendation that said road be established at a width of 60 feet.
- (4). A list of persons, if any, interested in lands over which said road passes who consented to the establishment of the road and waived all claims to damages.
- That no person interested in lands through which the road passes refused to consent to the establishment of the road and claimed damages.
- (6). A description of each tract of land over which said road passes, with the name and place of residence or address of the owners, lessees, claimants or incumbrancers and the quantity of area of land taken from each tract.
- (7). That the probable cost of the construction of the road, including all necessary bridges, culverts, and all clearing, grubbing and grading, will be \$ _ _ \bigcirc _ _ .

- (8). In conjunction with the establishment of the Rose Road as a County Road, the Board agreed to vacate the unused Holmes Road right-of-way to the adjoining property owners:
- (9). The property owners agree to the construction of a cul-de-sac by the Public Works Department at the end of the established Rose Road.

and the Board having examined the report of the Engineer, the map and the petition, the written consent and waivers of damages, and all other papers on file in the proceedings, and listened to and considered all testimony and documentary evidence adduced for the establishment of the road, and all persons interested in lands to be taken having consented to the establishment of said road and having waived their claims to damages therefor, and the Board being satisfied that the said road would be of public utility.

IT IS ORDERED BY THE BOARD, all members concurring

that the road petitioned for by the Board of County Commissioners, and others will be established, as follows:

In the Southwest quarter of Section 27, Township 33 North, Range 4 East, W.M.;

That portion of road beginning at a point on the south right-of-way line of the Tyee Road #8300, a County Road, said point being approximately 1320 feet west of the center of said Section 27, thence running South on the line between the West 1/2 and E 1/2 of the Southwest 1/4 of said Section 27 a distance of approximately 2265 feet;

and as shown upon the map of the Engineer, and that from henceforth said road shall be a County Road of 60 feet in width, and that the same be opened according to law; and that said road is hereby named and designated as the: ROSE ROAD #8301.
