AN ORDINANCE VACATING PORTIONS OF ALLEYS & STREETS
LOCATED IN FIRST PLAT OF SHIPS HARBOR ADDITION

TO THE CITY OF ANACORTES

WHEREAS, the City Council has been duly petitioned to vacate certain alleys and streets lying within First Plat of Ships Harbor Addition to the City of Anacortes; and

WHEREAS, the City Council did, by resolution, set a public hearing date to consider said vacation; and

WHEREAS, said hearing was held on December 2, 1991, and no protests were received and the City Council having considered the records and files herein; now, therefore,

THE CITY COUNCIL OF THE CITY OF ANACORTES DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The following described streets and alleys be and they are hereby vacated:

That portion of the alley lying between Lots 1 and 2 and Lots 15 & 16, Block 15, First Plat of Ships Harbor Addition to the City of Anacortes.

South 15 feet of D Avenue abutting Lot 16, Block 15. First Plat of Ships Harbor Addition to the City of Anacortes and extending to the centerline of the alley lying within said Block 15, if projected northerly.

That portion of D Avenue lying westerly of and immediately adjacent to the vacated portion of D Avenue abutting Lot 1, Block 15, First Plat of Ships Harbor Addition to the City of Anacortes extending westerly 6 feet from said vacated portion of D Avenue.

The west one-half of that certain alley abutting Lots 9 and 10, Block 10, First Plat of Ships Harbor Addition to the City of Anacortes.

The north 15 feet of D Avenue abutting Lot 10, Block 10, First Plat of Ships Harbor Addition to the City of Anacortes and extending to the centerline of the alley in said Block 10, if projected southerly.
