A RESOLUTION OF THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF SKAGIT COUNTY, WASHINGTON, APPROVING AND CONFIRMING THE ASSESSMENTS AND ASSESSMENT ROLL OF LOCAL UTILITY DISTRICT NO. 11, WHICH HAS BEEN CREATED AND ESTABLISHED FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING AND INSTALLING A WATER SYSTEM AND APPURTENANCES WITHIN THE ROCKPORT AREA OF THE DISTRICT, AS PROVIDED BY RESOLUTION NO. 1470, AND LEVYING AND ASSESSING THE COST AND EXPENSE THEREOF AGAINST THE LOTS, TRACTS, PARCELS OF LAND AND OTHER PROPERTIES AS SHOWN ON THE ROLL, AND PROVIDING FOR THE COLLECTION THEREOF.

WHEREAS, the assessment roll levying the special assessments against properties located in Local Utility District (LUD) No. 11 in Public Utility District No. 1 of Skagit County, Washington (the "District"), has been filed with the Secretary of the Commission of the District as provided by law; and

WHEREAS, notice of the time and place of hearing thereon and making objections and protests to the roll was duly published at and for the time and in the manner provided by law, fixing the time and place of hearing thereon for December 10, 1991, at 6:00 p.m., local time, in the Aqua Room of the office of the District, 1415 Freeway Drive, Mount Vernon, Washington, and further notice thereof was duly mailed by the Secretary of the Commission to each property owner shown on the roll; and

WHEREAS, at the time and place fixed and designated in the notice, the hearing was held for the purpose of hearing all persons appearing at the hearing who wished to be heard, all written protests received were considered and all property owners who submitted such protests or their representatives appeared at the hearing, and the Commission, sitting and acting as a Board of Equalization for the purpose of considering the roll and the special benefits to be received by each lot, tract, parcel of land and other property shown upon such roll, including the increase and enhancement of the fair market value of each such parcel of land by reason of the improvement, considered the protest of one property owner to her two assessments and the Commission concurred with the protest, reduced the two assessments to one and agreed to pay toward the cost of the improvements the amount of that reduction from District funds.

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. The assessments and assessment roll of LUD No. 11, which has been created and established for the purpose of acquiring, constructing and installing a water supply system and appurtenances within the District, as provided by Resolution No. 1470, as the same now stand, shall be and the same are in all things and respects approved and confirmed in the total amount of \$59,815.32.

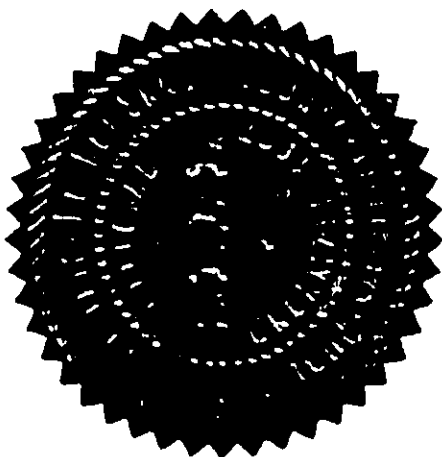
Section 2. Each of the lots, tracts, parcels of land and other property shown upon the assessment roll is determined and declared to be specially benefited by the improvements in at least the amount charged against the same, and the assessment appearing against the same is in proportion to the several assessments appearing upon the roll. There is levied and assessed against each lot, tract, parcel of land and other property appearing upon the roll the amount finally charged against the same thereon.

Section 3. The assessment roll as amended, approved and confirmed shall be filed with the Skagit County Treasurer for recording and the District Treasurer for collection, and the District Treasurer is authorized and directed to publish notice as required by law stating that the roll is in his hands for collection and that payment of any assessment thereon or any portion of such assessment can be made at any time within thirty days from the date of first publication of such notice without penalty, interest or cost, and that thereafter the sum remaining unpaid may be paid in twenty (20) equal annual installments. The estimated interest rate on the installments of assessments is established at 6.75% per annum. The first installment of assessments shall become due and payable during the thirty-day period succeeding the date one year after the date of first publication by the District Treasurer of notice that the assessment roll is in his hands for collection, and annually thereafter each succeeding installment shall become due and payable in like manner. If the whole or any portion of the assessment remains unpaid after the first thirty-day period, interest upon the whole unpaid sum shall be charged at the rate as determined above, and each year thereafter one of the installments, together with interest due on the unpaid balance, shall be collected. Any installment not paid prior to the expiration of the thirty-day period during which such installment is due and payable shall thereupon become delinquent. Each delinquent installment shall be subject, at the time of delinquency, to a charge of 12% penalty levied on both principal and interest due upon that installment, and all delinquent installments also shall be charged interest at the rate above. The collection of such delinquent installments shall be enforced in the manner adopted by law.
