MEMORANDUM OF LEASE

This Memorandum of Lease is made as of this day of April, 1992, by and between ARMADA VANCOUVER COMPANY, a Washington corporation (hereinafter, "Lessor"), and SEATTLE-FIRST NATIONAL BANK, a national banking association (hereinafter, "Lessee"), who agree as follows:

- 1. <u>Lease Term and Premises</u>. 
