Commencing at the East 1/4 corner of said Section 2, from which the Northeast corner of said Section 2 bears North 3 degrees 52'00" East; thence North 88 degrees 19'00" West, along the South line of said Southeast 1/4 of the Northeast 1/4 of Section 2, 643.77 feet to the Southeast corner of said subdivision, and the True Point of Beginning; thence North 3 degrees 22'57" East, along the East line of said subdivision, 330.01 feet; thence North 88 degrees 19'00" West, parallel with said South line of said subdivision, 160.00 feet; thence South 3 degrees 22'57" West, parallel with said East line of said subdivision, 330.01 feet to said South line of said subdivision; thence South 88 degrees 19'00" East, along said South line 160.00 feet to the True Point of Beginning; EXCEPT the East 80 feet thereof; AND ALSO EXCEPT County road, known as the Bridgewater Raod, along the South line thereof.
