RECORDED MEMORANDUM OF LEASE

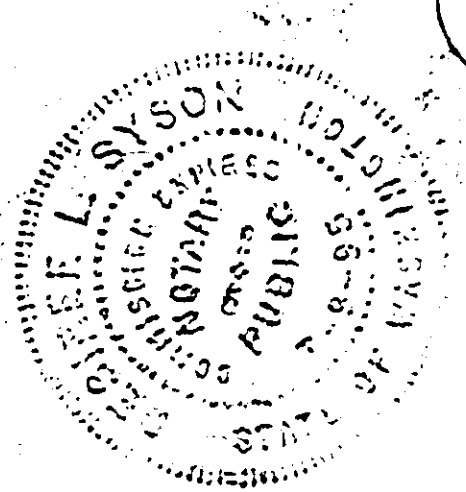
