





#### **NOTES**

# SURVEY DESCRIPTION

### Parcel "A"

That portion of the Northwest 1/4 of the Northwest 1/4 of Section 20, Township 36 North, Range 4 East, W.M., lying Westerly of the L. M. Abbey (Friday Creek) Road, EXCEPT the North 530.00 feet thereof.

TOGETHER WITH a non-exclusive easement for ingress, egress and utilities over and across the South 30.00 feet of said North 530.00 feet.

#### Parcel "B"

That portion of the Northeast 1/4 of the Northeast 1/4 of Section 19, Township 36 North, Range 4 East, W.M., lying Easterly of the centerline, or thread, of Friday Creek, EXCEPT the North 530.00 feet thereof.

TOGETHER WITH a non-exclusive easement for ingress, egress and utilities over and across the South 30.00 feet of the North 530.00 feet of that portion of the Northeast 1/4 of the Northeast 1/4 of said Section 19, lying Easterly of said centerline of Friday Creek.

### Parcel "C"

That portion of the Southwest 1/4 of the Northwest 1/4 of Section 20, Township 36 North, Range 4 East, W.M., described as follows:

Beginning at the Northwest corner of said Section 20; thence South 0° 17' 44" East, along the West line of said Section, a distance of 1,331.92 feet to the Northwest corner of said Southwest 1/4 of the Northwest 1/4; thence South 88° 51' 50" East, along said North line a distance of 1,280.47 feet to an intersection with the Westerly Margin of the County road, said point being the TRUE POINT OF BEGINNING; thence South 31° 33' 00" East along said Westerly margin, 71.29 feet; thence North 88° 51' 50" West 210 feet, more or less, to the centerline, or thread, of Friday Creek; thence Northerly along said centerline, or thread, to the North line of said Southwest 1/4 of the Northwest 1/4 of said Section 20; thence South 88° 51' 50" East along said North line to the TRUE POINT OF BEGINNING.
