

#### LEGAL DESCRIPTION

Tract "C" of Mount Vernon Short Plat No. MV - 2 - 86, approved January 6, 1986 and recorded January 6, 1986 in Book 7 of Short Plats at page 64, under Auditor's File No. 8601060030, records of Skagit County, Washington and being a portion of the West Three Quarter's (W  $\frac{3}{4}$ ) of the Northwest Quarter (NW  $\frac{1}{4}$ ) of the Southwest Quarter (SW  $\frac{1}{4}$ ) of Section Sixteen (16), Township Thirty-four (34) North, Range Four (4) East of the Willamette Meridian.

SUBJECT TO those exceptions and reservations contained in deed from the State of Washington recorded under Auditor's File No. 127165, reserving to the grantor all oil, gases, coal, ores, minerals, fossils, ect., and the right of entry for opening, developing and working the same and providing that such rights shall not be exercised until provision has been made for full payment of all damages sustained by reason of such entry.

Right of State of Washington or its successors, subject to payment of compensation therefore, to acquire rights of way for private railroads, skid roads, flumes, canals, water courses or other easements for transporting and moving timber, stone, minerals and other products from this and other property, as reserved in deed referred to above.

AND SUBJECT TO an Easement for sidewalk and incidental purposes to the City of Mount Vernon, a Municipal Corporation of the State of Washington, as recorded September 18, 1979, under Auditor's File No. 7909180047, affecting the West 7 feet of said Tract "C".

AND SUBJECT TO an Easement for overflow parking purposes, including the terms and conditions thereof, between LaVenture Partners, grantee, and James G. Caviezel and Margaret Caviezel, husband and wife, and Robert W. Chronister and Mary C. Chronister, husband and wife, grantor's, by that instrument dated September 5, 1978 and recorded April 16, 1980 under Auditor's File No. 8004160056, records of Skagit County, Washington.

AND SUBJECT TO those notes contained upon the face of said Mount Vernon Short Plat No. MV - 2 - 86, as follows:

- I. Short Plat Number and Date of Approval shall be included in all deeds and contracts.

- 3. Sewage Disposal by Mount Vernon City Sewer.
- 4. Zoning Classification;





## EASEMENT PROVISIONS

An Easement is hereby reserved for and granted to the Puget Sound Power and Light Company, the Continental Telephone Company of the Northwest, Inc., the Cascade Natural Gas Corporation, the Public Utility District No. I of Skagit County and TCI Cablevision of Washington, Inc., and their respective successors or assigns, under and upon the exterior ten (10) feet parallel and adjacent to the street frontage of Lots I and 2 of this Short Plat, as shown hereon, in which to install, lay, construct, renew, operate, maintain and remove utility systems, lines, fixtures and appurtenances attached thereto, for the purpose of providing this Short Plat and other property with electric, telephone, gas, water and television service together with the right to enter upon the lots at all times for the purposes stated, with the understanding that any grantee shall be responsible for all unnecessary damage it causes to any real property owner in the Short Plat by the exercise of rights and privileges herein granted.
