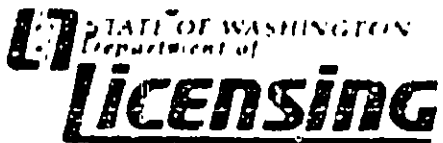

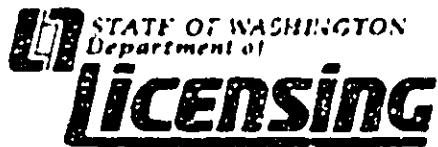

That portion of the Southeast 1/4 of the Southeast 1/4 of Section 27, Township 35 North, Range 5 East, W.M., described as follows:

Beginning at a point on the South line of said Southeast 1/4 of the Southeast 1/4, which is 726.41 feet West of the Southeast corner of said subdivision; thence North 17 degrees 24' West 304.75 feet; thence Northwest to a point on the West line of said subdivision which is 450 feet North of the Southwest corner of said Southeast 1/4 of the Southeast 1/4; thence North along the West line of said subdivision to the South bank of the Skagit River; thence Southeast along the South line of the Skagit River to a point 400 feet (measured at right angles thereto) East of the West line of said Southeast 1/4 of the Southeast 1/4; thence South along a line which is parallel to and 400 feet East of the West line of said Southeast 1/4 of the Southeast 1/4 to a point which is 30 feet North (measured at right angles thereto) of the South line of the tract herein described; thence East and South along a line which is parallel to and 30 feet North and East of the South and West line of the herein described tract to a point East of the Point of Beginning; thence West to the point of beginning, EXCEPT County road rights-of-way; ALSO EXCEPT that portion thereof lying Westerly of the following described line:

Begin at the Southwest corner of the Southeast 1/4 of the Southeast 1/4 of said Section 27, said point being South 89 degrees 41'00" West 1,343.81 feet from the Southeast corner of said Section 27; thence North 2 degrees 45'00" East along a fence line existing on December 4, 1989 to the Southerly line of the Skagit River, the terminus of this line description.

TOGETHER WITH an easement for ingress, egress and utilities to serve a single family residence only, over, across and under the East 40 feet of Lot 1 of Short Plat No. 10-90, approved March 16, 1990, and recorded March 23, 1990, in Volume 9 of Short Plats, Pages 214 and 215, under Auditor's File No. 9003230007, being a portion of the South 1/2 of Section 27, Township 35 North, Range 5 East, W.M., as granted by instruments recorded under Auditor's File Nos. 9001190044 and 9403240093.
