A RESOLUTION OF THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1
OF SKAGIT COUNTY, WASHINGTON, AMENDING, APPROVING AND
CONFIRMING THE ASSESSMENTS AND ASSESSMENT ROLL OF BIG LAKE
LOCAL UTILITY DISTRICT NO. 16, WHICH HAS BEEN CREATED AND
ESTABLISHED FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING AND
INSTALLING A WATER MAIN AND APPURTENANCES WITHIN THE
DISTRICT, AS PROVIDED BY RESOLUTION NO. 1519-91, AND LEVYING
AND ASSESSING THE COST AND EXPENSE THEREOF AGAINST THE
SEVERAL LOTS, TRACTS, PARCELS OF LAND AND OTHER PROPERTY
SHOWN ON THE ROLL, AND PROVIDING FOR THE COLLECTION
THEREOF.

WHEREAS, the assessment roll levying the special assessments against properties located in Local Utility District ("LUD") No. 16 in Public Utility District No. 1 of Skagit County, Washington (the "District"), has been filed with the Secretary of the Commission of the District as provided by law; and

WHEREAS, notice of the time and place of hearing thereon and making objections and protests to the roll was duly published at and for the time and in the manner provided by law, fixing the time and place of hearing thereon for September 21, 1994, at 7:00 p.m., local time, in the gymnasium of Big Lake Elementary School located at 1676 Highway 9, Mount Vernon, Washington, and further notice thereof was duly mailed by the Secretary of the Commission to each property owner shown on the roll; and

WHEREAS, at the time and place fixed and designated in the notice, the hearing was held for the purpose of hearing all persons appearing at the hearing who had filed a written protest and who wished to be heard, and the Commission, sitting and acting as a Board of Equalization for the purpose of considering the roll and the special benefits to be received by each lot, parcel and tract of land shown upon such roll, including the increase and enhancement of the fair market value of each such parcel of land by reason of the improvement

(1) considered the protest of six property owners to the financial burden of the assessment and the Commission denied the request to lower or remove such assessment (Roll #33, 4135-029-018-0009; Roll #213, 3863-000-070-0050; Roll #80, 340435-1-010-0605, 4404-000-007-0100, 340435-1-010-0700; Roll #451, 4025-000-007-0006; Roll #186, 4135-042-024-0004; Roll #121, 4135-020-016-0000, 4135-020-014-0002);

(2) considered the protest of five property owners that they have existing sources of water and will not use the new water system and the Commission denied the request to lower or remove such assessment (Roll #468, 340436-0-037-0001; Roll #36, 3882-000-035-0006; Roll #55, 340436-0-001-0102; Roll #534, 340425-0-001-0006, 340425-0-015-0000; Roll #63, 3882-000-029-0103, 3882-000-029-0004; Roll #173, 3882-000-036-0005; Roll #174, 3882-000-037-0020, 3882-000-029-0202);

(3) considered the protest by one property owner that the lot was not buildable and the Commission denied the request to lower or remove such assessment (Roll # 301, 3862-000-039-0105);

(4) considered the protest by one property owner to the request that the assessments be based on a different methodology and that their lot was not buildable and at staff recommendation removed the assessment to the parcel. However, if a water service is requested for said property the owners of that

property shall have paid prior to such connection a charge-in-lieu of assessment which shall be at least the equivalent of those assessments which would have been applied to that property (Roll #508, 3862-000-037-0008);

(5) considered the protest by one property owner that the water pipeline does not front his property and at Staff recommendation removed the assessment to said parcel because the property was not fronted by a water pipeline (Roll #389, 340435-4-014-0001);

(6) considered the protest by one property owner that the property was not buildable and at Staff recommendation removed the assessment to said parcel because it was documented by the Skagit County Board of Equalization that it was an unbuildable lot. However, if a water service is requested for said property the owners of that property shall have paid prior to such connection a charge-in-lieu of assessment which shall be at least the equivalent of those assessments which would have been applied to that property (Roll #518, 340436-0-006-0602);

(7) considered the protest by one property owner that they were being assessed twice for contiguous property with common ownership and at Staff recommendation removed one assessment from property that was contiguous and owned by the same property owner. However, if a water service is requested for said property the owners of that property shall have paid prior to such connection a charge-in-lieu of assessment which shall be at least the equivalent of those assessments which would have been applied to that property (Roll #319, 3941-000-039-0001; Roll #388, 3941-000-040-0008);

Being fully informed, after due consideration;

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. The amendments recited above should be and hereby are made and carried out, and the assessments and assessment roll of LUD No. 16, which has been created and established for the purpose of acquiring, constructing and installing a water main and appurtenances within the District, as provided by Resolution No. 1519-91, as the same now stand, shall be and the same are approved and confirmed in all things and respects in the total amount of \$2,186,151.84.


Section 2. Each of the lots, tracts, parcels of land and other property shown upon the assessment roll is determined and declared to be specially benefited by this improvement in at least the amount charged against the same, and the assessment appearing against the same is in proportion to the several assessments appearing upon the roll. There is levied and assessed against each lot, tract, parcel of land and other property appearing upon the roll the amount finally charged against the same thereon.

Section 3. The assessment roll as approved and confirmed shall be filed with the District Treasurer for collection and the District Treasurer is authorized and directed to publish notice as required by law stating that the roll is in his hands for collection and that payment of any assessment thereon or any portion of such assessment can be made at any time within thirty days from the date of first publication of such notice without penalty, interest or cost, and that thereafter the sum remaining unpaid may be paid in thirty (30) equal annual installments. The interest rate on the installments of assessments is established at 5.75% per annum. The first installment of assessments shall become due and payable during the thirty-day period succeeding the date one year after the date of first publication by the District Treasurer of notice that the assessment roll is in his hands for collection and annually thereafter each succeeding installment shall become due and payable in like manner. If the whole or any portion of the assessment remains unpaid after

the thirty-day period, interest upon the whole unpaid sum shall be charged at the rate above, and each year thereafter one of the installments, together with interest due on the unpaid balance, shall be collected. Any installment not paid prior to the expiration of the thirty-day period during which such installment is due and payable shall thereupon become delinquent. Each delinquent installment shall be subject, at the time of delinquency, to a charge of 12% penalty levied on both principal and interest due upon that installment, and all delinquent installments also shall be charged interest at the rate above. The collection of such delinquent installments will be enforced in the manner provided by law.

ADOPTED by the Commission of Public Utility District No. 1 of Skagit County, Washington, at a regular open public meeting thereof this 3rd day of October, 1994.
