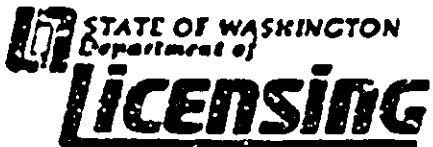
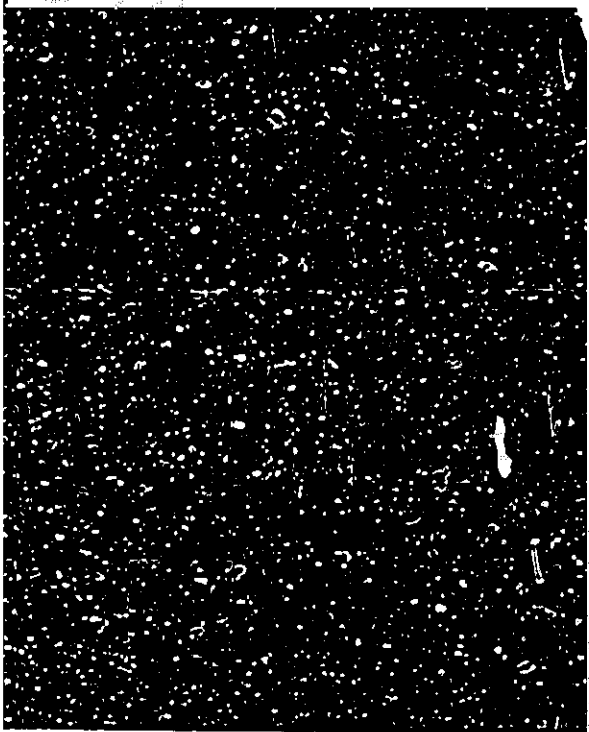

That portion of the West 1/2 of the Southeast 1/4 of the Northwest 1/4 of Section 22, Township 34 North, Range 3 East, W.M., described as follows: *22
