That portion of the following described property lying within the North 704 feet of the Northeast  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of Section 17, Township 35 North, Range 7 East, W.M.

That portion of the South 416 feet of the North 832 feet of the Northeast  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of said Section 17, lying Easterly of the centerline of a 10 foot road as hereinafter described, EXCEPT the East 450 feet of said tract:
