

LEGAL DESCRIPTION

PARCEL A LEOT I

ALL THAT PORTION OF TRACT 3 OF PLATE II, ANACORTES TIDE AND SHORE LANDS, ACCORDING TO THE OFFICIAL MAP THEREOF IN THE OFFICE OF THE STATE LAND COMMISSIONER AT OLYMPIA, WASHINGTON, DESCRIBED AS FOLLOWS
