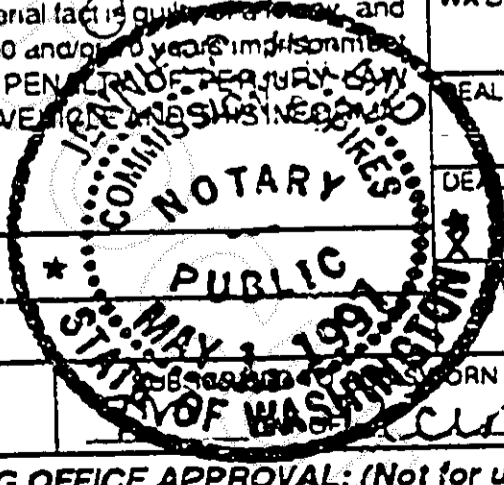

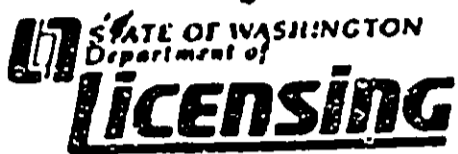

The land referred to herein is situated in the County of SKAGIT, State of Washington, and is described as follows:

Tract 2, Short Plat 12-76, approved April 2, 1976, and recorded April 6, 1976, under Auditor's File No. 832831, in Volume 1 of Short Plats, Page 118, records of Skagit County, Washington, being a portion of Government Lot 5, and of the Southeast 1/4 of the Northwest 1/4 of Section 6, Township 35 North, Range 5 East, W.M., EXCEPT that portion thereof described as follows:

Beginning at the intersection of the West line of said Government Lot 5, and the South line of the North 550 feet of said Government Lot 5; thence South 89 degrees 11' 39" East along said South line, a distance of 689.37 feet to the true point of beginning; thence South 0 degrees 48' 21" West, a distance of 126.42 feet; thence South 89 degrees 11' 39" East, a distance of 176 feet; thence North 0 degrees 48' 21" East, a distance of 120 feet, more or less, to the North line of the South 110 feet of the Northwest 1/4 of the Southeast 1/4 of the Northwest 1/4 of said Section; thence North 89 degrees 36' 41" West along said North line, a distance of 95.5 feet, more or less, to the West line of said Southeast 1/4 of the Northwest 1/4; thence North 2 degrees 39' 27" West along said West line, a distance of 6.57 feet to a point South 89 degrees 11' 39" East of the true point of beginning; thence North 89 degrees 11' 39" West, a distance of 80.20 feet to the true point of beginning.
