


DESCRIPTION

PARCEL "A":

Lot 8 of Anacortes Short Plat No. 91-008, as approved November 4, 1991, and recorded November 5, 1991, in Volume 10 of Short Plats, Pages 27 and 28, under Auditor's File No. 9111050069, records of Skagit County, Washington; being a portion of Blocks 508, 509, 510, and 511, NORTHERN PACIFIC ADDITION TO ANACORTES, according to the plat thereof recorded in Volume 2 of Plats, Page 9, records of Skagit County, Washington.

PARCEL "B":

That portion of Lot 1, Short Plat No. ANA-91-008, approved November 4, 1991, and recorded November 5, 1991, in Volume 10 of Short Plats, Pages 27 and 28, records of Skagit County, Washington, described as follows:

BEGINNING at the Northwesterly most corner of said Lot 1; thence South 3° 15' 51" West 256.99 feet along the West line of said Lot 1; thence South 79° 58' 12" East 26.65 feet (called 26.25 feet on previous descriptions); thence North 10° 01' 48" East 30.00 feet to the Westerly most corner of Lot 7 of said Short Plat No. ANA-91-008; thence North 3° 15' 51" West 241.81 feet along the West line of Lot 7 (also being the East line of Lot 1, to the Northwest corner of said Lot 7; thence South 72° 20' 06" West 32.12 feet along the South margin of Georgia Place, as the same is shown on the face of said Short Plat No. ANA-91-008 to the POINT OF BEGINNING.

PARCEL "C":

That portion of Lot 7, Short Plat No. ANA-91-008, approved November 4, 1991, and recorded November 5, 1991, in Volume 10 of Short Plats, Pages 27 and 28, records of Skagit County, Washington, described as follows:

BEGINNING at the Northwest corner of said Lot 7, Short Plat No. ANA-91-008; thence North 72° 20′ 06″ East 28.01 feet along the South margin of Georgia Place, as the same is shown on the face of said Short Plat No. ANA-91-008; thence South 9° 11′ 41″ West 253.17 feet to the Westerly most corner of said Lot 7; thence North 3° 15′ 51″ East 241.81 feet along the West line of said Lot 7 to the POINT OF BEGINNING.

PARCEL "D":

Lot 9 of Anacortes Short Plat No. 91-008, as approved November 4, 1991, and recorded November 5, 1991, in Volume 10 of Short Plats, Pages 27 and 28, under Auditor's File No. 9111050069, records of Skagit County, Washington; being a portion of Blocks 508, 509, 510, and 511, NORTHERN PACIFIC ADDITION TO ANACORTES, according to the plat thereof recorded in Volume 2 of Plats, Page 9, records of Skagit County, Washington.

ALL OF THE ABOVE BEING SUBJECT TO and TOGETHER WITH easements, reservations, restrictions, covenants and other instruments of record. Situate in the County of Skagit, State of Washington.

UTILITY EASEMENT

An easement is hereby reserved for and granted to CITY OF ANACORTES, PUGET POWER, G. T. E., CASCADE NATURAL GAS CORP., AND TCI CABLE VISION OF WASHINGTON, INC. and their respective successors and assigns under and upon the exterior ten (10) feet of front boundary lines of all lots and tracts as shown on the face of the plat and other utility easements, if any, shown on the face of the plat, in which to install, lay, construct, renew, operate, maintain and remove utility systems, lines, fixtures, and appurtenances attached thereto, for the purpose of providing utility services to the subdivision and other property, together with the right to enter upon the lots and tracts at all times for the purposes stated, with the understanding that any grantee shall be responsible for all unnecessary damage it causes to any real property owner in the subdivision by the exercise of rights and privileges herein granted.


