of the County of Skagit in the State of Washington, in consideration of the sum of One Dollar (\$1.00) and Other Good and Valuable Consideration, have bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Skagit, the following described parcel of land situated in Skagit County, in the State of Washington, to-wit:

A parcel of land in the Southeast quarter of the Southeast quarter of Section 25, Township 35 N., Range 5 East, W. M., being more particularly described as follows:

Beginning at the Northeast corner of Section 25, Township 35 N., Range 5 East, W. M.; THENCE S 0 degrees 05' 01" E along the East line of said section for a distance of 2712.35' to the East 1/4 corner of Section 25; THENCE S 0 degrees 56' 25" W along the East line of said section a distance of 1346.58'; THENCE N 89 degrees 59' 30" W a distance of 868.80' to a point on the centerline of the right-of-way of South Skagit Highway as described in Short Plat 95-032, Vol. 12 of Short Plats, pg. 64; THENCE along the centerline of said right-of-way S 72 degrees 04' 12" W a distance of 33.43' to the beginning of a curve, said curve having a central angle of 3 degrees 12', a radius of 5729.58', a chord bearing of S 70 degrees 28' 12" W, and a chord distance of 319.96'; THENCE continuing along the centerline of said right-of-way along said curve, an arc distance of 320.00' to the end of said curve; THENCE along the centerline of said right-of-way S 68 degrees 52' 12" W a distance of 156.70'; THENCE S 0 degrees 13' 18" E a distance of 32.11' to the TRUE POINT OF BEGINNING; THENCE N 68 degrees 52' 12" E a distance of 77.48'; THENCE S 21 degrees 07' 48" E a distance of 40.00'; THENCE S 68 degrees 52' 12" W a distance of 60.00'; THENCE N 21 degrees 07' 48" W a distance of 35.00'; THENCE S 68 degrees 52' 12" W a distance of 50.00'; THENCE N 21 degrees 07' 48" W a distance of 5.00'; THENCE N 68 degrees 52' 12" E a distance of 32.52' to the TRUE POINT OF BEGINNING.

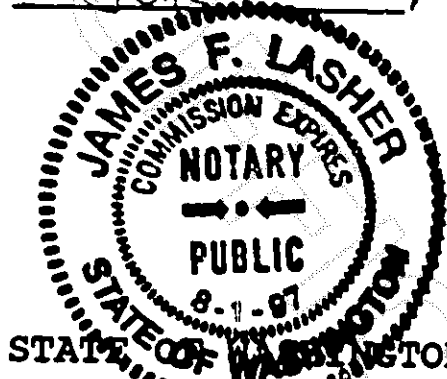
EXCEPT existing county road right-of-way.
