RESOLUTION NO. 94-11-94

A RESOLUTION CONFIRMING THE FINAL ASSESSMENT ROLL
FOR RUID NOS. 89001 AND 89002

WHEREAS, the Swinomish Indian Tribal Community is a federally recognized Indian Tribe organized pursuant to Section 16 of the Indian Reorganization Act of 1934; and

WHEREAS, the Swinomish Indian Senate is the governing body of the Swinomish Indian Reservation located near the Town of LaConner, Washington; and

WHEREAS, the Swinomish Indian Senate in Resolution Nos. 90-8-82 and 90-10-118, respectively, ordered the creation of Reservation Utility Improvement Districts (RUID) Nos. 89001 and 89002 to provide sanitary sewer and domestic water improvements. Each of these resolutions directed preparation of a preliminary assessment roll.

WHEREAS, the Swinomish Utility and Environmental Services Authority (Utility Authority) prepared a preliminary assessment roll for both sanitary sewer and domestic water improvements, filed it with the Tribal Comptroller, and published notice of such roll.

WHEREAS, the Utility Authority and/or its designees held public hearings on June 22, 1994, and July 13, 1994, during which testimony was received protesting the assessments.

WHEREAS, the Utility Authority at a special meeting on November 10, 1994, voted to recommend that the Senate approve the attached modified assessment roll; and

WHEREAS, the Swinomish Utility Ordinance directs that the Swinomish Indian Senate by resolution confirm the final assessment roll; NOW THEREFORE,

BE IT RESOLVED that the Swinomish Indian Senate hereby confirms the attached final assessment roll for sanitary sewer and domestic water improvements in RUID Nos. 89001 and 89002.

AND FURTHER, THAT the Swinomish Indian Senate will by separate resolution establish the time period within which assessments or installments thereof shall be paid, as well as the interest rate, penalty, and other terms relating to the financing and collection of such assessments. Once such resolution is approved, the Swinomish Indian Senate shall place the approved assessment roll in the hands of the Tribal Comptroller. The Swinomish Indian Senate shall then publish notice in the local newspaper once a week for two consecutive weeks stating alternatively that the roll is in the Tribal Comptroller's hands.

The 10-day appeal period begins upon date of publication.

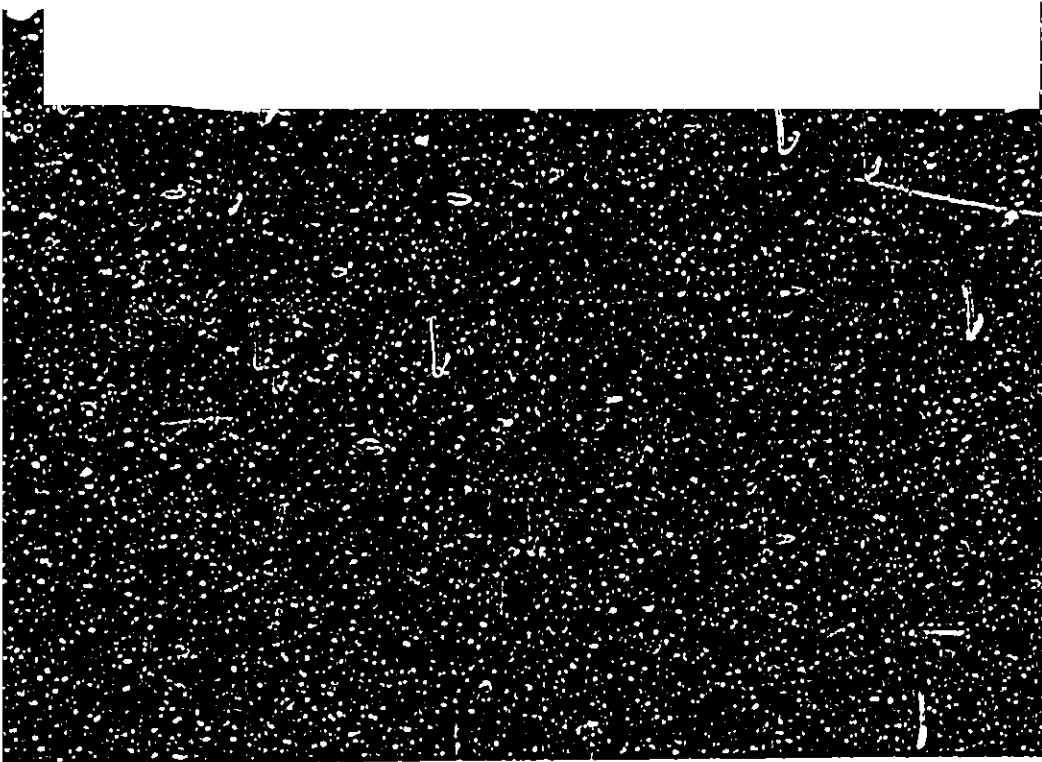
