RESOLUTION NO. 97-8- 51

A Resolution Confirming Additions to Final Assessment Roll for RUID Nos. 89001 and 89002 and Providing for Payment Terms

WHEREAS, the Swinomish Indian Tribal Community is a federally recognized Indian Tribe organized pursuant to Section 16 of the Indian Reorganization Act of 1934; and

WHEREAS, the Swinomish Indian Senate is the governing body of the Swinomish Indian Reservation located near the Town of LaConner, Washington; and

WHEREAS, the Swinomish Indian Senate in Resolution Nos. 90-8-82 and 90-10-118, respectively, ordered the creation of Reservation Utility Improvement Districts (RUID) Nos. 89001 and 89002 to provide sanitary sewer and domestic water improvements; and

WHEREAS, the final assessment roll for sanitary sewer and domestic water improvements was approved by the Swinomish Indian Senate by Resolution No. 94-11-94, and payment terms for fee lots and leased or occupied trust lots were established by the Senate by Resolution No. 94-12-101; and

WHEREAS, notices of proposed additions to the assessment roll naming the beneficial owners of interests in trust lots have been duly published and mailed; and

WHEREAS, no written protests to the proposed additions to the assessment roll were filed with the Swinomish Utility Authority, and no protests to the proposed additions to the assessment roll were made during a hearing held by the Senate's designate on August 14, 1997; and

WHEREAS, Article VI, Sections 1(a), (c), (f), (h), (k), (l), (m), (r), and (s) of the Swinomish Constitution provide authority for the Swinomish Senate to adopt this Resolution; **NOW THEREFORE**,

BE IT RESOLVED by the Swinomish Indian Senate that the attached additions to the final assessment roll for sanitary sewer and domestic water improvements in RUID Nos. 89001 and 89002 are hereby approved; and

BE IT FURTHER RESOLVED, that assessments for unleased and vacant trust lots shall continue to bear interest at the same rate as all other lots; and

BE IT FURTHER RESOLVED, that assessment payments for such unleased and vacant trust lots shall not become due until such lots are leased or occupied unless the Senate, by resolution,

BE IT FURTHER RESOLVED, that payment terms for fee lots and for leased or occupied trust lots shall continue to be as set forth in Resolution No. 94-12-101 unless modified in the future by Senate resolution.
