This Declaration of Plat Notation Release is made on this 3/5 day of ______, 1998 by Skagit County, a municipal corporation of the State of Washington, for the benefit of the citizens of Skagit County, Washington.

- On February 7, 1996, the Western Washington Growth Management Hearings Board A. issued an order (the "GHMHB Order") invalidating certain zoning code and certain other ordinances of Skagit County. The County appealed that order to the Superior Court of the State of Washington.
- During the pendency of such appeal, the County required that all plats approved by the B. County bear the following notation:

WARNING: This development may be affected by the terms of the Western Washington Growth Management Hearings Board's Invalidity Order in Case No. 95-2-0065. That invalidity order and

its effect on this development is the subject of a pending court appeal before the Washington State Court of Appeals Case No. 38585-2-I. If the County is unsuccessful in the appeal, it may affect your ability to proceed with the development, and may result in your having to restore the property to its prior condition.

Attached hereto as Exhibit A is a list of plats and their recording numbers on which the notation was made.

C. On June 25, 1998, the Supreme Court of the State of Washington resolved the appeal in favor of the County and issued an order vacation the GMHB Order. See Skagit Surveyors and Engineers. LLC v. Friends of Skagit County, _____ Wn.2d ____, P.2d ____, 1998 WL 344531 (June 25, 1998) (No. 64798-4). The County now desires to document in the official records of Skagit county, Washington, the Court's decision to vacate the GMHB Order and release each Plat Notation as a result of such decision.

Now Therefore, the County hereby declares as follows:

As of June 25, 1998, the plat Notation referenced above shall be deemed deleted from, and shall be of no further force or effect for, the plats listed on attached Exhibit A and any other plat recorded in the official records of Skagit County, Washington bearing such notation. Except with respect to the deletion of the Plat Notation, nothing herein shall be deemed to modify, amend or change any plats recorded in the official records of Skagit County, Washington.
