LOAN SUBORDINATION AGREEMENT

1. Bank of America National Trust and Savings Association ("Lender") is the owner and holder of that certain Deed of Trust dated August 4, 1998, recorded August 20, 1998, under Auditor's File No. 9808200119, records of Skagit County, Washington, (hereafter referred to as the "\$1,750,000 Deed Of Trust") of which the Grantor is Stanislaw Properties, L.L.C., a Washington limited liability company ("Owner").

Lender is also the owner and holder of that certain Note in the face amount of 2. \$665,000.00 (hereinafter referred to as the "Note"), secured by a Deed of Trust encumbering certain property described therein dated April 30, 1996, by and among Jeanne M. Janicki Gross, Mary T. Janicki McGoffin, Michael F. Janicki, John P. Janicki, Robert W. Janicki, Peter W. Janicki, and Sarah J. Janicki Rutherford, as Grantor, Rainier Credit Company, as Trustee, and Lender as Beneficiary, which Deed of Trust was recorded in the official records of Skagit County, Washington, on May 7, 1996, under Recording No. 9605070054. Pursuant to Consent to Transfer and Assumption of Liability Agreement, dated March 26, 1998, Stanislaw Properties, L.L.C., a Washington limited liability company ("Owner") assumed and agreed to pay and perform the \$665,000 Deed of Trust. Pursuant to Deed of Trust Modification and Spreading Agreement dated August 14, 1998, the lien of the \$665,000 Deed of Trust was spread to cover all of the Property described in the \$1,750,000 Deed of Trust and on Schedule A attached hereto. The Note, the Deed of Trust described in this paragraph 2, and all related loan documents, including without limitation the Consent to Transfer and Assumption of Liability Agreement, dated March 26, 1998, and the Deed of Trust Modification and Spreading Agreement dated August 14, 1998, are collectively referred to herein as the "\$665,000 Deed of Trust."

3. Owner is the owner of all the real property described in the \$665,000 Deed of Trust, as spread by the Deed of Trust Modification and Spreading Agreement dated August 14, 1998, and on Schedule A attached hereto.

4. Lender hereby unconditionally subordinates the lien, security interest and rights granted by the \$1,750,000 Deed of Trust to the lien, security interest and rights granted by the \$665,000 Deed of Trust, and to all advances or charges made or accruing under the \$665,000 Deed of Trust, including any extension or renewal thereof, to the same effect as though the \$665,000 Deed of Trust had been placed on record before the \$1,750,000 Deed of Trust.

5. It is understood and agreed that a default under the \$665,000 Deed of Trust shall constitute a default under the \$1,750,000 Deed of Trust, and Lender, upon such default, may, at its option, without demand or notice, declare the whole sum secured by the \$1,750,000 Deed of Trust with interest thereon to be immediately due and payable, or Lender may, at its option, cure the default and add any amounts paid in curing the default to the amount due under the \$1,750,000 Deed of Trust.

6. This Agreement shall be the whole and only agreement between the parties hereto with regard to the subordination of the \$1,750,000 Deed of Trust to the \$665,000 Deed of Trust, and shall supersede and cancel any prior agreements regarding subordination including, but not limited to, those provisions, if any, contained in the \$1,750,000 Deed of Trust which provides for the subordination of the lien or charge thereof to a deed of trust or deeds of trust to be thereafter executed.

7. This Loan Subordination Agreement is entered into by Lender only and solely for the benefit of itself and the present and future owners and holders of the indebtedness secured by the \$665,000 Deed of Trust and not for the benefit of, nor in favor of, any other person or party. The \$1,750,000 Deed of Trust is in full force and effect and asserted by Lender except as expressly hereby subordinated.

8. This Loan Subordination Agreement shall not impair the validity or priority of the \$1,750,000 Deed of Trust as to real property not described in the \$665,000 Deed of Trust.

9. It is contemplated that this Loan Subordination Agreement will be filed for record after the \$665,000 Deed of Trust is filed, and Lender will insert in this Agreement where indicated the actual filing dates and number of the \$665,000 Deed of Trust and such insertions shall be binding upon Owner.

10. The heirs, administrators, assigns and successors in interest of Lender shall be bound by this Agreement. The words "Deed of Trust" shall refer to "mortgage" where appropriate.
