If the transfer in location is between two different countles, prepare this form in duplicate and have each recorded in its respective county.
- C. Manufactured Home Removal From Real Property Application (complete boxes 1, 2, 3, 4 and 5). Use when tilling a manufactured home whose title has been previously eliminated.
