MUTUAL GRANT OF EASEMENTS

This MUTUAL GRANT OF EASEMENTS (this "Agreement") is made this 20 day of 1999 by and between TRILLIUM CORPORATION, a Washington corporation ("Trillium") and ROBERT E. REID ("Reid").

RECITALS

- A. Reid is the owner of certain real property located in Section 3, Township 35 North, Range 4 East, Skagit County, Washington (the "Reid Property").
- B. Trillium is the owner of certain real property located in Section 3, Township 35 North, Range 4 East, Skagit County, Washington (the "Trillium Property").
- C. Trillium desires to grant to Reid an easement over the Trillium Property, and Reid desires to grant to Trillium an easement over the Reid Property.

AGREEMENT

NOW, THEREFORE, the parties hereto agree as follows:

1. Grant of Easement from Trillium to Reid. Trillium hereby grants and conveys to Reid a nonexclusive easement for the purpose of ingress, egress and utilities, with the additional right to construct, reconstruct and maintain the easement road, in and to all of the following described real property which is located on the Trillium Property:

An easement for ingress, egress and utilities over, under, or across that portion of the Trillium Property being sixty (60) feet wide. The centerline of said easement will be the centerline of the existing forest road as indicated on Exhibit A-1 attached hereto.

A 60 foot easement for ingress, egress and utilities over, under or across the Southwest 60 feet of the SW ¼ NE ¼ of Section 3, Township 35 North, Range 4 East, as indicated on Exhibit A-2 attached hereto.

2. Grant of Easement from Reid to Trillium. Reid hereby grants and conveys to Trillium a nonexclusive easement for the purpose of ingress, egress and utilities, with the additional right to construct, reconstruct and maintain the easement road, in and to all of the following described real property which is located on the Reid Property:



An easement for ingress, egress and utilities over, under, or across that portion of the Reid Property being sixty (60) feet wide. The centerline of said easement will be the centerline of the existing forest road as indicated on Exhibit A-1 attached hereto.

A 60 foot easement for ingress, egress and utilities over, under or across the Northeast 60 feet of the NW ¼ SE ¼ of Section 3, Township 35 North, Range 4 East, as indicated on Exhibit A-2 attached hereto

- 3. <u>Easements to Run with the Land</u>. This Agreement and the easements granted hereunder shall run with the land and shall inure to the benefit of and be binding upon the parties hereto and their respective transferees, heirs, executors, administrators and assigns.
- 4. Attorneys' Fees. In the event a dispute arises over this Agreement or the obligations and benefits contained herein, the prevailing party in any suit or action to enforce this Agreement shall recover its reasonable attorneys' fees and other costs or litigation from the other party or parties to the suit.

IN WITNESS WHEREOF the parties hereto have executed this Mutual Grant of Easements Agreement as of the day and year first written above.




