PERSONAL REPRESENTATIVE'S DEED

- 1. **GRANTOR; NONINTERVENTION POWERS.** The undersigned Grantor, ANITA O. SANCHEZ, is the duly appointed, qualified and acting personal representative of the Estate of PABLO CANALES SANCHEZ, who died on April 16, 1994. Grantor was appointed Personal Representative of the Estate on January 25, 1999 upon filing of an oath in the Superior Court of the State of Washington under Skagit County Cause No. 99-4-00029-3. By Order Granting Letters of Administration entered on January 21, 1999 in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision. Grantor, ANITA O. SANCHEZ, is the surviving spouse of the decedent PABLO CANALES SANCHEZ.
- 2. **DESCRIBED COMMUNITY PROPERTY:** Included among the property of the Estate of PABLO CANALES SANCHEZ was his interest in real property described as follows:

The Northeast quarter (NE ½) of that part of the East half (E ½) of Government Lot 2 lying Westerly of the county road and Southerly of that certain tract conveyed to School District No. 49, by deed dated April 20, 1915 and recorded October 21, 1943, under Auditor's File No. 366502, records of Skagit County, Washington, except the North 25 feet thereof all in Section 3, Township 35 North, Range 3, East of the Willamette Meridian.

Reserving to the grantors, a perpetual easement and right of way for roadway over the East 30 feet of said tract.

- 3. **CONVEYANCE**. Grantor hereby bargains, sells and conveys to ANITA O. SANCHEZ, as her separate estate, the above described property located in Skagit County, Washington, and any and all interest the estate has in the Described Property together with all after acquired title of the Grantor therein.
- 4. **LIMITATION OF COVENANTS**. Grantor expressly limits the covenants of this deed to those expressed herein and excludes all covenants arising or to arise by statutory or other implication.
