## LEGAL DESCRIPTION:

The West 566 feet of Tracts "E", "F" and "G" of "BIG LAKE WATER FRONT TRACTS", according to the Plat thereof recorded in Volume 4 of Plats, page 12, records of Skagit County, Washington.

- 1. REAL ESTATE CONTRACT BEING MODIFIED. This agreement modifies that certain Real Estate Contract dated September 11, 1998 between MARIE A. RYAN, as "Seller" and NANCY W. SPEARS AND DAVID L. REBER AND DIXIE L. REBER as "Buyer". Said contract was recorded under Skagit County Auditor recording no. 9809150138. Said contract is being modified as stated herein and except for those specific provisions set forth in this Modification Agreement, all other provisions of the Real Estate Purchase and Sale Agreement shall remain unchanged.
- 2. <u>BUYER'S INTEREST ASSUMED BY SUCCESSOR.</u> The "Buyer's" interest in said contract is now held by BRENT M. BARKER AND LINDA L. BARKER, HUSBAND AND WIFE, hereafter called ("BARKER"), which interest was acquired by Statutory Warranty Deed dated September 14, 1999 and recorded with the Skagit County Auditor.
- 3. PRINCIPAL PAID DOWN TO \$54,000.00. Paragraph 4.(a) PRICE, is hereby modified and BARKER agrees to pay the principal balance of said contract down to \$54,000.00 as of the effective date of closing of their purchase of the subject property.
- 4. PAYMENTS MODIFIED. Paragraph 4.(c) PAYMENT OF AMOUNT FINANCED BY SELLER is changed as follows. "Buyer agrees to pay the sum of \$54,000.00 as follows:

MODIFICATION OF REAL ESTATE CONTRACT Page 1 of 3 / m-jhbark3921m \$444.49 or more at buyer's option on or before the 1st day of November, 1999 at the rate of 9.00% per annum on the declining balance thereof; and a like amount or more on or before the 1st day of each and every month thereafter until paid in full. Interest from NANCY W. SPEARS and DIXIE L. REBER shall be prorated to closing and interest for the remaining month of October, 1999 shall be collected at closing and remitted to MARIE A. RYAN.

NOTWITHSTANDING THE ABOVE, THE ENTIRE BALANCE OF PRINCIPAL AND INTEREST IS DUE IN FULL NOT LATER THAN OCTOBER 1, 2003.

- 5. WASTE. Paragraph 17. "WASTE" is hereby modified to read as follows:
  "Buyer shall keep the property in good repair and shall not commit or suffer waste or
  willful damage to or destruction of the property." (The last sentence of the original
  paragraph 17 (requiring consent of Seller to remove commercial timber) is hereby deleted.)
- 6. <u>NOTICES</u>. Paragraph 25. "NOTICES" is hereby amended to add BARKER'S address for notices as follows: BRENT M. BARKER and LINDA L. BARKER, 1010 5th Street, Mukilteo, WA 98275.
- 7. <u>OPTIONAL PROVISION ALTERATIONS.</u> Paragraph 29. "OPTIONAL PROVISION ALTERATIONS" is hereby removed in its entirety.
- 8. <u>OTHER TERMS REMAIN UNCHANGED.</u>

All other terms and conditions of the Real Estate Contract dated September 11, 1999 remain unchanged.
