That portion of the Northwest 1/4 of the Northwest 1/4 of Section 17, Township 35 North, Range 6 East, W.M., and the East 1/2 of the Northeast 1/4 of the Northeast 1/4 of Section 18, Township 35 North, Range 6 East, W.M., described as follows:

Commencing at the Southeast corner of the Northeast 1/4 of the Northeast 1/4 of said Section 18; thence North 01 degrees 52' 40" East along the East line thereof, a distance of 24.43 feet to the North line of Lyman-Hamilton Highway and the point of beginning of this description; thence continuing North 01 degrees 52'40" East, a distance of 142.24 feet; thence South 87 degrees 25'08" East, a distance of 0.48 feet to a fence line; thence North 00 degrees 02'17' East along said fence line, a distance of 33.49 feet which point is approximately 0.6 feet West of the East line of said Section 18; thence North 03 degrees 02'56" East along said fence line, a distance of 76.99 feet which point is approximately 1 foot East of the East line of said Section 18; thence North 00 degrees 39'46" East along said fence line, a distance of 145.68 feet which point is approximately 2 feet West of the East line of said Section 18; thence North 85 degrees 14.50" West parallel with the South line of Highway 20, a distance of 502.83 feet; thence South 01 degrees 52'40" West parallel with the East line of said Section 18, a distance of 468.86 feet to the North line of Lyman-Hamilton Highway; thence North 86 degrees 16'40" East along said North line, a distance of 306.15 feet to the point of curvature of a curve to the right having a radius of 4870 feet; thence Easterly along said curve through a central angle of 2 degrees 21'20", and an arc length of 200.22 feet to the point of beginning of this description.
