## ROAD MAINTENANCE AGREEMENT

THIS AGREEMENT, made and entered into this \_\_\_\_\_\_\_ day of October, 1999, by and between ALTA M. CRUTCHER ("Crutcher"), and STEVEN M. VAN ALLEN & MARYANNE M. VAN ALLEN, husband and wife ("Van Allen").

FOR AND IN CONSIDERATION of the granting by Crutcher to Van Allen of a non-exclusive easement for ingress, egress and utilities over the North 30 feet of Lots 3 & 4, Skagit

County Short Plat # 97-0004, by separate Grant of Easement of even date, THE PARTIES AGREE AS FOLLOWS:

- Van Allen shall be solely responsible for the maintenance and upkeep of any road, driveway, or other access over or across any portion of the easement area granted by Crutcher, including but not limited to the clearing of brush or foliage from the easement area, and the removal of downed trees or other obstructions from the easement area. Notwithstanding the foregoing, Van Allen shall use no herbicidal sprays within the easement area without permission of Crutcher, and in addition any downed or felled trees removed from the easement area which had previously been located on Crutcher's property shall remain the property of Crutcher.
- 2. Crutcher, and her heirs, successors and assigns, shall have the unrestricted use of any road, driveway or access over or across the said easement, provided that such use does not interfere with Van Allen's use thereof.
- 3. Van Allen may install and maintain a gate across the easement area, provided that should the gate be locked, Crutcher and/or her designees, heirs, successors or assigns shall be provided keys thereto.
- 4. This agreement is binding on the parties hereto, and their heirs, successors and assigns, and shall be part and parcel of the easement granted by Crutcher and referenced above.
