That portion of the Northwest 1/4 of the Northwest 1/4 of Section 17, Township 35 North, Range 6 East, W.M., and the East 1/2 of the Northeast 1/4 of the Northeast 1/4 of Section 18, 1/2 of the Northeast 1/4 of East, W.M., described as follows: Township 35 North, Range 6 East, W.M., described as follows:
