## EXCEPTIONS:

As Follows:

- 1. All maintenance and construction of private roads shall be the responsibility of the lot owners and the responsibility of maintenance shall be in direct relationship to usage of road.
- 2. Short Plat Number and Date of Approval shall be included in all Deeds and Contracts.
- 3. Sewage Disposal Individual Septic Tanks
- 4. Water Individual Well
- 5. Water of sufficient quantity and/or quality for normal domestic purposes is not provided at the time of filing the plat. The buyer should inquire and investigate as to the availability of said water. Skagit County requires a 100' radius well control zone surrounding each well. The buyer of each lot should inquire and investigate as to the location and existence of adjoining systems before constructing any buildings or drilling any wells and the buyers should cooperate in the locations of wells to prevent problems with these overlapping control zones.
