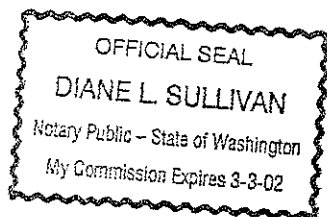

PARCEL A:

That portion of Government Lot 1, Section 23, Township 36 North, Range 1 East of the Willamette Meridian, described as follows:

Beginning at the South Quarter section corner of said Section 23; thence South  $88^{\circ}48'30''$  East along the South line thereof, for a distance of 200.07 feet; thence North  $52^{\circ}51'12''$  East for a distance of 932 feet to the Northeasterly line of Government Lot 1; thence Westerly along the Northeasterly line of said Government Lot 1 for a distance of 937 feet to a point which lies North  $05^{\circ}12'25''$  East for a distance of 827 feet from the point of beginning of this description; thence South  $05^{\circ}12'25''$  West, a distance of 827 feet to the point of beginning of this description.

EXCEPTING therefrom the following described parcel:

Beginning at a point on the South line of said Section 23 which lies 200.07 feet Easterly from the South quarter section corner thereof; thence North  $88^{\circ}48'30''$  West along said South line for a distance of 200.07 feet to said South quarter section corner; thence North  $05^{\circ}12'25''$  East for a distance of 54.91 feet; thence South  $88^{\circ}48'30''$  East for a distance of 205.95 feet; thence North  $52^{\circ}51'12''$  East for a distance of 888.90 feet to the Northeasterly line of said Government Lot 1; thence Southeasterly along said Northeasterly line for a distance of 37 feet to a point which bears North  $52^{\circ}51'12''$  East for a distance of 932.34 feet from the point of beginning of this description; thence South  $52^{\circ}51'12''$  West for a distance of 932.34 feet to the point of beginning of this description.

TOGETHER WITH tidelands of the second class, above the line of mean low tide, situated in front of, adjacent to, or abutting on the above described portion of Government Lot 1 in said Section 23.
