

2. Zoning — Rural (RU); Comprehensive Plan Designation — Rural Reserve.

- 3. Water Individual wells; Water will be supplied from individual water systems. Contact the Health Department to determine if additional water quality or quantity testing will be required for building permit approvals. Skagit County requires a 100 foot radius well protection zone for new individual water systems. The zone must be contained entirely on the lot owned in fee simple and/or be provided through appropriate covenants or easements. Present and future owners of lots with an existing well shall preserve a 100 foot radius well protection zone for existing well improvement or replacement.
- 4. Sewer Individual on—site sewage systems, Alternative systems—are proposed for all Lots of this short plat which may have special design, construction and maintenance requirements see Health Officer for details.
- 5. Basis—of-bearings Assumed S03°19'49"W on the East line of the Southeast Quarter of Section 20. 6. This survey was accomplished by field traverse using: 2 second digital electronic Total Station, and meets or exceeds the standards contained in WAC. 332-130-090

- 8. All maintenance and construction of roads shall be the responsibility of the homeowners association with the lot owners as members. See Maintenance Agreements filed under A.F. No.'s 9403300041, and L99910280105.
- 9. No building permit shall be issued for any residential and/or commercial structures which are not, at the time of application, determined to be within an official designated boundary of a Skagit County Fire District.
- 10. Change in location of access, may necessitate a change of address, contact Skagit County Planning and Permit Center.

- 12. The total impervious surface of the proposal shall be limited to 5 percent of the total lot area, unless the proposed development provides mitigation that will collect runoff from the proposed development will treat that runoff, if necessary to protect groundwater quality and discharge that collected runoff into a groundwater infiltration system SCC 14.06.330 (2)(ii)

No lawn watering shall be permitted between June 1st and September 30th, provided if the proposed development connects to an existing public water supply as described in subsection (i), or if the proposed development is drawing water from a confined aquifer, then this landscape watering restriction shall not apply.
