	The undersigned subordinator and owner agrees as follows:		
1.	NOOKACHAMP HILLS L.L.C., a Washington Limited Liability Company referred to herein as "subordinator", is the owner and holder of a mortgage dated November 1, 1999 which is recorded in volume of Mortgages, page, under auditor's file No, records of Skagit County.		
2.	Washington Federal Savings referred to herein as "lender", is the owner and holder of a mortgage dated		
3.	HANSELL HOMES INC., A Washington Corporation referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.

6.	It is understood by the parties hereto that "lender" would n without this agreement.	It is understood by the parties hereto that "lender" would not make the loan secured by the mortgage in Paragraph 2 without this agreement.

This agreement shall be the whole and only agreement between the parties hereto with regard to the subordination of the lien or charge of the mortgage first above mentioned to the lien or charge of the mortgage in favor of "lender" above referred to and shall supercede and cancel any prior agreements as to such, or any, subordination including, but not limited to, those provisions, if any, contained in the mortgage first above mentioned, which provide for the subordination of the lien or charge thereof to a mortgage or mortgages to be thereafter executed.
