MULTIPLE DWELLING UNIT SERVICE AGREEMENT

1. EASEMENTS; ACCESS. Owner hereby grants, bargains and conveys to Company an irrevocable easement in gross across, under and over the Premises as necessary or desirable for the routing, installation, maintenance, service and operation of the Equipment (as hereinafter defined), and any of Owner's equipment used in connection with provision of the Services, and the marketing and provision of the Services. In consideration of Company's investment in the Equipment and other valuable consideration, for a period of time ending upon the earlier of (a) the date of termination of this Agreement or (b) the 7th (seventh) anniversary of the effective date of this Agreement, and to the extent allowable under Federal law, Owner will not, without the prior written consent of Company, operate or install or permit the operation or installation of any other antenna, receiver, converter, cable or other signal amplification system on the Premises for use in connection with television or radio equipment.
- 4. **TERM.** This Agreement will be effective on the date hereof and continue for a period of <u>15</u> years (the "Initial Term"), and will automatically renew for terms of <u>5 (five)</u> year(s) (each a "Renewal Term"), unless either party gives the other written notice at least six months prior to the end of the Initial Term or then-effective Renewal Term, as appropriate.
