ORDINANCE NO. 438

AN ORDINANCE VACATING A PORTION OF F STREET LYING EAST OF THE EAST BOUNDARY OF BLOCK 15 OF MILLER'S FIRST ADDITION TO CONCRETE, AND WEST OF THE WEST BOUNDARY OF BLOCK 3A, OF SAID PLAT, UPON THE PETITION OF SKAGIT COUNTY, A WASHINGTON MUNICIPAL CORPORATION.

WHEREAS, a petition for vacation of a street or alley has been submitted by Skagit County, a municipal corporation, and

WHEREAS, the requested vacation is for:

That portion of the unopened right-of-way of "F" Street, lying Southerly of the Northerly boundary of Lot 10, extended Westerly, Block 3A of Miller's First Addition to Concrete, filed in Plats of Skagit County, Washington, and lying Northerly of a line beginning at the Southeast corner of Lot 16, Block 15, and ending at the Southwest corner of Lot 11, Block 3A, of said Plat. That portion of said street proposed to be vacated is approximately 220 feet in length and 70 feet in width, and is illustrated on the attached map.

WHEREAS, upon site review, the following has been determined that the vacation of this street does not interfere with any likely or possible construction and/or extension of the said street. There is sufficient and adequate access to the affected Blocks and Lots.

WHEREAS, a Public Hearing was held on April 12, 1999, at which the Town Council received testimony of interested parties, and

Whereas, the Town Council has determined that it is in.

THEREFORE, The Town Council do hereby ordain as follows:

1. That the above-described street right-of-way be vacated, subject to any utility easements of record.

2. The Town of Concrete reserves an easement, including the right to grant and convey easements and franchises, over, across and under the vacated right-of-way for all utility purposes, including construction, repair and maintenance of public utilities and services. No structure shall be constructed on said easement without prior written consent of the Town.



- The street vacation petition fee of \$120.00, together with 50% of the appraised value of land, be paid to the Town of Concrete prior to vacation of any streets or alleyways. If said sum is not so paid within one hundred eighty (180) days from the date of this ordinance, it shall be null and void. (The Town Clerk may accept the Skagit County Assessor's valuation of adjacent property, in lieu of an appraisal, in his or her discretion.)
- 4. All payments shall be made in cash or cashiers check to the Town Clerk. There shall be no installment payments. Upon receipt of full payment, the Town Clerk/Treasurer shall cause a certified copy of this ordinance to be recorded with the Skagit County Auditor as evidence of full payment.
- 5. This ordinance shall be effective upon passage and publication as provided by law.
