EXHIBIT "A"

That portion of Government Lot 6 of Section 31, Township 35 North, Range 2 East W.M., described as follows:

Beginning at the section corner common to Sections 29, 30, 31 and 32, Township 35 North, Range 2 East W.M., situated in Skagit County, Washington; thence Easterly in Government Lot 1, Section 32, along the high tide line, a distance of 172.68 feet; thence South to the intersection of the section line between Sections 31 and 32 and the North line of the Burlington-Northern Railroad right-of-way; thence West in Government Lot 6, Section 31, along the North line of the Burlington-Northern right-of-way to a point on the right-of-way which is 75 feet West of the right-of-way change (from 100 feet to 75 feet) at Station 325 + 85; thence South along a line which intersects the North line of the Fidalgo Bay Road at a point 525 feet from the West line of the Weaverling Road to the South line of the Burlington Northern right-of-way, said point being the true point of beginning; thence continue South along said line to the North line of the Fidalgo Bay Road; thence Northwesterly along said North line 11.4 feet, more or less, to a point on a line running South 40 degrees 57'37" West from the true point of beginning; thence North 40 degrees 57'37" East, a distance of 339.26 feet, more or less, to the true point of beginning.
